Sir,

In producing herewith one accused person named Situ Roy (22yrs) S/O- Naresh Roy of Dada Bhai Colony, W.No- 43, Newar Shiv Mandir, PS Bhaktinagar Dist Jalpaiguri under arrest along with following seized articles viz,

1. 10 (Ten) bottles of Himali Cold 60 up country Spirit (each bottle containing 600 ml, total 6000 ml.)

I, ASI Dipak Karmakar S/o Lt. Dulal Karmakar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Situ Roy (22yrs) S/O- Naresh Roy of Dada Bhai Colony, W.No- 43, Near Shiv Mandir, PS Bhaktinagar Dist Jalpaiguri to the effect that today on 19.03.2024 at about 18.15 hrs received a source information that one person is randomly selling liquor at Limbu Busty road under Bhaktinagar PS without any valid license.

Accordingly I informed the matter to the I/C PS and as per his kind direction I along with C/ 374 Debraj Biswas had been to Limbu Busty road under Bhaktinagar PS to verify the veracity of source information. After reaching there and as identified by the source found that one person was selling illicit liquor at Limbu Busty road under Bhaktinagar PS. Subsequently, I along with my force cordoned the area and able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above.

Further being searched the above noted seized articles was found from his possession. On demand he failed to produce any valid license/papers for selling of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named Situ Roy (22yrs) S/O- Naresh Roy of Dada Bhai Colony, W.No- 43, Near Shiv Mandir, PS Bhaktinagar Dist Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19.45hrs to 20.15 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Situ Roy (22yrs) S/O- Naresh Roy of Dada Bhai Colony, W.No- 43, Shiv Mandir, PS Bhaktinagar Dist Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
