Subject: - F.I.R.

Sir,

In producing herewith one accused person named Santosh Sah (36), S/O Rajendra Sah of Green Park, Pokajote, W/No. 46, PS. Pradhan Nagar, Dist. Darjeeling under arrest along with the following articles under proper seizure:-

One nylon bag containing 12 (Twelve) bottles of 60 UP Himalayan gold India made Liquor containing 600 ml in each bottle i.e. total (12 x .600 lts) = 7.2 ltrs marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A-1".

I, SI Bandhan Roy of Pradhan Nagar PS, SPC would like to lodge this written complaint against accused person named Santosh Sah (36), S/O Rajendra Sah of Green Park, Pokajote, W/No. 46, PS. Pradhan Nagar, Dist. Darjeeling to the effect that today on 18.03.2024 at 20.40 hrs I along with force left the PS to perform special RT mobile van duty at PS area vide Pradhan Nagar PS GDE No. 1038, dated 18.03.2024. During my duty at 21.50 hrs I received specific source information that one person selling and storing huge quantity of illicit liquor without any valid license at his hotel styled as Santosh Hotel, near Sinclairs Hotel, Mallaguri, W/No. 46, PS. Pradhan Nagar, Dist. Darjeeling. Accordingly, I am sharing the information with you.

As per your kind order and direction, I along with ASI Biplab Kr Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar all of Pradhan Nagar PS left for Mallaguri to verify the veracity of the source information. On reaching there and as identified by the source I along with force conducted raid in a hotel styled as Santosh Hotel, near Sinclairs Hotel, Mallaguri, W/No. 46, under Pradhan Nagar PS and manage to apprehended the owner of the said hotel. On being asked he disclosed his identity as noted above. On being search the above noted seized articles were found in his possession. On demand he failed to produce any valid license/papers for selling and storing of such illicit liquor. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his wrongful gain. Then, I seized and labeled the above mentioned illicit distilled liquor under proper seizure list from his possession and marked as Exhibit "A", and subsequently, arrested the above mentioned detained person namely Santosh Sah (36), S/O Rajendra Sah of Green Park, Pokajote, W/No. 46, PS. Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities on the spot. The whole process of seizure and label was made in between 22.20 hrs to 23.00 hrs at the spot for violating the norms of the Bengal Excise Act.


Therefore, I pray before your good self that a specific case may kindly be initiated against accused Santosh Sah (36), S/O Rajendra Sah of Green Park, Pokajote, W/No. 46, PS. Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
