Dear Sir,

I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL , P.S Matigara do here by lodge this complain against Ritesh Srivastav address: Panchanai, Dagapur, P.S: Pradhannagar, Dist: Darjeeling and Abhisek Srivastav C/O Rajani Enterprise Panchanai, Dagapur Dist Darjeeling, to the effect that on 20.03.2024 at about 14.50 hrs in pursuance of a tip off about unauthorised use of electricity , myself along with Pranab Sikdar, S.O S&LP of Darjeeling Regional office, WBSEDCL , Bhusan Lama, Khokon Roy and other staff have been to the place of Ritesh Srivastav address: Panchanai, Dagapur, P.S: Pradhannagar, Dist: Darjeeling and inspected the premises of Ritesh Srivastav address: Panchanai, Dagapur, P.S: Pradhannagar, Dist: Darjeeling and Abhisek Srivastav C/O Rajani Enterprise Panchanai, Dagapur Dist Darjeeling.

During inspection it has been observed that said Ritesh Srivastav is a Commercial consumer of WBSEDCL having ID no 400005773 for his premises with Contractual loads 2.94 KVA.

As Abhisek Srivastav C/O Rajani Enterprise using the premise of Suseendra Pal Singh where service connection for con ID 412004986 and meter no : SF604708 is deemed disconnected, is found consuming electrical energy by unauthorized extension of line and using power at the same place without clearing outstanding energy bill 26540.76, LPSC amount 39809.75 (Total 66350.51) from the meter no: L1080668 of commercial consumer Ritesh Srivastav (Con ID: 412222810) which is violation of law and punishable under section 135 (1) (e) & section 150 of Electricity Act. On enquiry it is also learned that the illegal usage is going on for approximately last three months.

Hence prepare notice, inspection memo by mentioning all minute details , as observed and also seized the energy sub meter 1 phase 2 wire bearing sl no : 895382 manufactured by : P.T.M.S in question with approx 20 Mtr low voltage PVC wire blue coloured single core 10 sqmm after preparing the proper seizure list duly signed by witnesses and representative of the premise owner. Supply copies of required documents to the representative for future reference.

So it is requested that a case under section 135 (1) (e) / 150 of Electricity Act for Ritesh Srivastav, and Abhisek Srivastav C/O Rajani Enterprise may please be registered and arrange for its investigation.
