Sir,

In producing herewith one arrested accused person named Chandra Mohan Roy (40) s/o Panchanan Roy of Shelterbari, PO Balaram, PS Bhorer Alo, Dist. Jalpaiguri along with following articles under proper seizure list.

1. Fourteen (14) sealed bottles of "HIMALAYAN GOLD 60 UP COUNTRY SPIRIT" each Bottle containing 600 MI [Total 8.4 Litres] each bottle costs MRP Rs. 150/-.

I, ASI Rabi Tamang of Ambari Out Post under Bhorer Alo P.S. SPC would like to lodge this written complaint against the above noted accused person to the effect that today on 19.03.2024 at about 16.45 hrs I, received a specific source information that the above noted accused person is selling illicit liquor at his shop situated at Sahudangi haat. Accordingly, I diarized the fact in General Diary vide Ambari OP GDE No 684, Dated 19.03.2024 and informed to Officer-In-Charge of Ambari OP under Bhorer Alo PS and as per his kind order and direction myself along with C/ 505 Tapash Dutta, NVF/043 Ranjan Das, NVF/119 Krishna Baidya all of Ambari OP left for Sahudangi Haat under Bhorer Alo PS to work out the information in hand.

At around 17.10 hours I along with force arrived at Sahudangi Haat and being identified by my source we held raid at the shop of the above noted accused person and managed to apprehend him. On being asked he disclosed his identity as Chandra Mohan Roy (40) s/o Panchanan Roy of Shelterbari, PO Balaram, PS Bhorer Alo, Dist. Jalpaiguri. On, being searched of his shop in presence of witnesses and the apprehended accused person recovered above noted illicit liquor from his shop. On demand he failed to produce any valid license/papers for selling and storing of illicit liquor. On further interrogation he stated that he has been involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above noted person named Chandra Mohan Roy (40) s/o Panchanan Roy of Shelterbari, PO Balaram, PS Bhorer Alo, Dist. Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 19.03.2024 in between 17.15 hrs to 17.45 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Chandra Mohan Roy (40) s/o Panchanan Roy of Shelterbari, PO Balaram, PS Bhorer Alo, Dist. Jalpaiguri and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
