On that day at morning around 5:45 am a call has been received from a number (9641025230) has been received by our company officials in which we knew about the theft of materials. Also it was mentioned that the same incident was happened previously. After verifying we found only 43 false ceiling out of 162 keeping outside land of our godown area. The people around the godown area identify the abductors. Hence, our representative Mr Debasis Ghosh, Sr Accountant and Mr Sougata Saha, Jr Engineer have informed the whole matter to Mr Pratap Basak, SI of Ashighar Police Outpost immediately. He immediately took action with deployed an SI Agen Lepcha and his colleague for the investigation. The deployed officers started to investigate the matter by taking statement from different people and all. Finally, he is very confirmed about the censurable. He is also trying to his best to catch abductors. Now, the problem is about our work which is ongoing from last 1 year. Hence the following materials are very essential to complete the works.
