Subject: Complaint against husband.

Respected Sir,

I, Sujata Sah, D/O Mahesh Sah, R/O Sarat Chandra Pally,
Haider para, Siliguee, aged about 30 years,
state that I was married to one Deepak Kumar Sah, son of
Chatar Bhuj Sah, Resident of unknown,
~~son of~~ on 01 May 2014 at Bihar. At the time of marriage
my parents had to give 1 lac rupees in cash along with
2.5 Bhati gold, one gold chain (approx. 10gm) and one ring
approx. 5gm along with utensils made of pectal and silver at
the demand of my husband and in-laws.

Soon after the marriage, I discovered that my
husband was an alcoholic and he used to physically and
verbally abuse me under the influence of alcohol.
He was not even going to work after marriage even though
I was told during the time of marriage that he is
a dalal and engages in dalali of land sale. I remember
that in Jan 2015 he had physically assaulted me because
I denied to attend a friend's ^{celebration} ~~wedding~~ with him. Soon
after I delivered a baby girl in November 2015 but my
husband and in-laws were not happy because the
child was a girl. Even after that my husband has
physically abused me on multiple occasions and
he would also mentally torture me.

In December 2020, I left my husband
because he was not providing for me or my
daughters and since then I have not been

maintaining any contact with him.

However, he has come to Siliguri, where I live with my parents and daughter and he has been stalking me and giving threats.

In particular these instances have escalated since February 2023 and he keeps coming to my place of work - Bhagwati Apartment, Purjabipara Siliguri. He has been telling me, "Mera kaam adhura hai. Sabko maarengे uske baad jaenge." I fear for my and my daughter's life and therefore request you to take action against him as per law. I don't know where he lives but I have learnt from my well-wishers that he sleeps on the road and has no one to look after him.

The contents of the above complaint have been read over to me in my vernacular and I have understood the same. It has been drafted under my instructions.
