I, Smt. Subra Chakraborty Saha, the

that my marriage was solemnized on dt.
19.07.2015 at Kolkata, with Indrajit Aich,
S/O U. Milan Kanti Aich, but since after
my marriage my said husband started subjecting
me for physical & mental cruelty at my parents
home at Durga Nagar Colony, P.S.-Siliguri.
Even after the birth of a daughter namely,
Agomani Aich (Bgm.), he did not stop his
his atrocities on me for demand of dowry.

Sir, on dt. 19.03.2024 at about 08:30
pm, when my mother namely, Smt. Chhabi
Das w/o Lt. Sadanananda Saha and
me was at our house at Durga Nagar
Colony, Ward No. 4, P.S.-Siliguri, my said
husband, namely, Smt. Indrajit Aich,
demanded Rs. 20,000/- (Rupees twenty
laks) dowry from my mother and when
she along with me protested, & denied, he
started beating us brutally.

Sir, my said husband is very despicable
& dangerous in nature and ~~that~~ he has
threatened me for dire consequences if I will
enter in my mother's house at Durganagar
Colony.
