Respected Sir,

I Punam Sharma, W/O Ratnesh Sharma, R/o Champasari, South Palash, Vtc Palash, P.O Champasari, Dist Darjeeling West Bengal would beg to state as follows:

That 1) Shri Birender Roy, 2) Shri Nistish Roy, and 3) Shri Rathnesh Roy are our neighbours and are very troublesome as well as notorious persons and they quarrel with our family over every petty issues, moreover we had also lodged a complaint with Pradhan Nagar Police station dated 15/09/2021 over one such incident the copy of the same has been attached herewith as A1.

That today at around 9:30 am in the morning there was some problem with our cable and I was trying to fix it but all of a sudden wife of the said Shri Birender Roy shouted at me using filthy languages and after a heated discussion Shri Birender Roy in a drunken condition armed with lathi forcefully entered our house followed by his wife and his sons Shri Nistish Roy, and Shri Rathnesh Roy.

It is pertinent to mention here that at that time me, my mother-in-law namely Saroj Devi and my brother-in-law's wife namely Preeti Sharma were present in the house as our husband were out for their work, the said Shri Birender Roy, his wife and his two sons namely Shri Nistish Roy, and Shri Rathnesh Roy have mercilessly assaulted us with lathis and Shri Birender Roy and his sons have also violated my dignity by grabbing my private parts.

That sir my mother in law has been seriously injured while trying to save us, the said Shri Birender Roy has assaulted my mother in law with a thick lathi on her head and now she has been admitted to hospital.

Therefore I, request you to kindly register my complaint and please take necessary against the accused persons as per law.


