With due respect, I Anindra Majumder Sastri, S/o. Dr. Shib Shankar Sastri, residing at Akshaydeep Complex, Block-2B6, Second Floor, 28 Girish Ghosh Sarani, P.S. Siliguri, Dist. Darjeeling beg to state that today at about 1:00 P.M., when I was standing at the side of Bidhan Road, Opposite Tera Hotel, Siliguri, one staff of Siddharth Enterprise carrying two big boxes pushed behind me through such boxes. As I have just asked him to follow the road and public, he became furious and suddenly he has thrown such heavy weight boxes at my head. I sustained grievous bleeding injury on my forehead i.e. just above my eye. The said person has hit me with an intention to kill me. I got severe injuries, and I took medical care and treatment. Subsequently, I came to learn the name of said staff namely Satyam Sarkar, S/o. Late Santosh Sarkar, resident of Jaleswari Bazar, P.S. Bhaktinagar, Dist. Jalpaiguri.

Therefore, I request you to look into the matter and to take necessary legal action against said Satyam Sarkar. And for this kindness, I shall much oblige to you.
