I, Smt.Laxmi Majumdar (Mandal), W/o. Sri Debrata Mandal, D/o. Sri Jotin Majumdar, C/o. Sri Ashim Das, R/o. Tumul Para, Near Paul Para More, Ward No.04, P.S.Siliguri, Dist. Darjeeling would like to inform you that on 26/06/2013 one Hindu Marriage was solemnized between me and a person namely Sri Debrata Mandal, S/o. Sri. Paravash Mandal, R/o. Porajhar, Tinbatti Over Bridge, P.S. N.J.P., Dist. jalpaiguri as per Hindu Rites and customs at my above mention residence and during that time my as well as his family members were also presence and at the time of marriage as per demand of my husband and his family members my parents gave them a sum of Rs.50,000/- by ash and other house hole articles such as Khat, Desitable, T.V etc and after the aforesaid marriage, I went to my matrimonial house and started to live there with my husband as a huband and wife and it is also important to mention here that out of the said wedlock one Female child also born on 03.06.2015 namely Priti Mandal.

It is important mention here that after 4-5 months of my marriage I noticed that my above named husband coming home late night in drunken condition and after coming to home used to abuse me by using filthy languages and also pressurized me to bring more dowry

from my parental house when I denied to do the same at that time he became fercious and started to assaulted me with fist and blows and also torture me by the way of physically and mentally, however, I tolarated the same because at that time I was pregnant and I thought that he will change his behaviour after the baby is born, but nothing changed even after giving birth, he kept on torturing me and it is important to mention here that after the baby was born, he neglected to provide proper food or clothes to me and my aforesaid female child but I tolarated all those in-human torture of my husband and my in-laws with a hope in my mind that one day he will change but such day never come to my life.

It is pertinent to mention here that during the aforesaid period he had a several illicit relationship with a several women after it came to my knowledge when I told him that I will leave him and will reside in my parent's house then he became more ferocious and assaulted me with fist and blows, Utlimately, on
