Sir,

I, SI Binup Mahato of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Prahallad Barman (59yrs) S/O Lt Khargo Barman of Ambika Nagar PS New Jalpaiguri Dist.- Jalpaiguri under arrest along with following seized articles;

1. Eighteen (18) sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.

I am submitting a written complaint against the above noted accused person to the effect that on 19.03.24 at 17-05 hrs received source information that one person was selling Liquor illegally from his Hotel situated at South Colony, Over bridge under NJP PS to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself alongwith ASI Dhruva Mishra C/1462 Sajan Tamang, CV-306 Biswajit roy, CV-297 Putul Roy all of NJP PS, SPC left for South Colony to verify the veracity of information vide NJP PS GDE No. 990 Dated- 19.03.24. On arrival at the spot at 18-45 hrs it was found that one person mentioned above was selling liquor illegally from his Hotel to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above and also confessed that he is selling Id Liquor illegally from his Hotel near Over Bridge at South colony without any license. Thereafter in presence of witnesses I recovered eighteen (18) sealed Bottles of Himalayan gold country spirit 60Up, each bottle 600 ml from his possession from his shop and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked he failed to produce any document or license for selling the liquor. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 19-05 hrs to 19-55 (seizure Total approx 10.8 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Prahallad Barman (59yrs) S/O Lt Khargo Barman of Ambika Nagar PS New Jalpaiguri Dist.- Jalpaiguri and arrange for its investigation.
