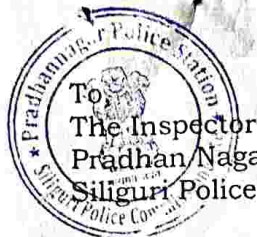

Sir,

In producing herewith (06) six accused persons namely (i) Ashish Sha (20 yrs) S/O Harindar Sah of Gurung Busty, PS- Pradhan nagar, Dist.- Darjeeling (ii) Santosh Mongar (27 yrs) S/O Late Mani Kumar Mongar of Dentam, PS- Namchi, Dist.- South Sikkim, Sikkim (iii) Suraj Mongar (43 yrs) S/O Late Krishna Kumar Mongar of Gurung Busty, PS- Pradhan Nagar, Dist.- Darjeeling (iv) Budhha Tamang (39 yrs) S/O Sonam Tamang of Vill- Bara Fapri, BSF Camp, PS- Bhaktinagar, Dist.- Jalpaiguri (v) Dipesh Gurung (36 yrs) S/O Dipak Gurung of Vill- Gurung Busty, PS- Pradhan Nagar, Dist.- Darjeeling and (vi) Krishna Subba (26 yrs) S/O Late Ganga Subba of Gurung Busty, PS- Pradhan Nagar, Dist.- Darjeeling under arrest and the following articles under seizure :-

(i) One iron made weapon locally called as "Bhojali" measuring 20 inch (approx) in length including its wooden butt recovered and seized from the possession of accused Ashish Sha, (ii) one iron made sharp cutting weapon locally called as "Bhojali" measuring approx 18 inch in length including wooden butt recovered and seized from the possession of accused Santosh Mongar, (iii) One iron made sharp knife measuring approx 8 inches in length recovered and seized from the possession of accused Suraj Mongar, (iv) One iron made breaking instrument locally called as "Sarashi" measuring 18 inches in length and one torch light recovered and seized from the possession of accused Budhha Tamang, (v) one iron made weapon locally called as "PUNCH" recovered and seized from the possession of accused Dipesh Gurung and (vi) one iron made screw driver and one instruments called as "PLUS" recovered and seized from the possession of accused Krishna Subba. I, ASI Manoj Kr Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted 06 (six) arrested accused persons and their 03/04 unknown associates who involve in this crime to the effect that on 23.03.2024 night at 21.45 hrs received a specific source information that about 09/10 persons assembled at Dagapur Play ground, under PS- Pradhan Nagar, Dist.- Darjeeling equipped with deadly weapons and were taking preparation for committing dacoit at Dagapur and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 1365 dated 23.03.2024. After getting the permission from you myself accompany with SI Golutam Mallick, ASI Jagannath Roy, C/1411 Ashok Roy, C/1415 Chandan Basak, C/1416 Dilip Barman and C/1413 Sujit Sarkar, all of Pradhan Nagar PS left for Dagapur Play ground under Pradhan Nagar PS to verify the veracity of the information. On the way, I informed the matter to RT van officer ASI Amar Raj Subba of Pradhan Nagar PS and directed him to come at Dagapur Play ground to accompany with us for holding raid at Dagapur Play ground. At about 21.55 hrs we reached at Dagapur Play ground, and at around 22.01 hrs night RT van officer ASI Amar Raj Subba along with his RT van force arrived at Dagapur Play ground, and accompanied us. Then I shared the information to all the above noted officers and force and briefed them accordingly. Thereafter, I contacted with my source and as pointed by the source we noticed that 09/10 persons assembled in a dark place at Dagapur Play ground and they were whispering in a very low voice. We cordoned the place with due care and caution.

On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehend above noted six (06) accused persons with deadly weapons in their possessions while 03/04 others managed to flee away from the spot taking the opportunity of darkness and open place. On interrogation, they disclosed their identities as noted above. On further interrogation they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoit at Dagapur and its surrounding areas.

Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 22.20 hrs to 23.25 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. I accordingly brought all the six (06) arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Dagapur and its surrounding areas.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted 06 (six) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Dagapur and its surrounding areas.

Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted six (06) arrested accused persons namely (i) Ashish Sha (20 yrs) S/O Harindar Sah of Gurung Busty, PS- Pradhan nagar, Dist.- Darjeeling (ii) Santosh Mongar (27 yrs) S/O Late Mani Kumar Mongar of Dentam, PS- Namchi, Dist.- South Sikkim, Sikkim (iii) Suraj Mongar (43 yrs) S/O Late Krishna Kumar Mongar of Gurung Busty, PS- Pradhan Nagar, Dist.- Darjeeling (iv) Budhha Tamang (39 yrs) S/O Sonam Tamang of Vill- Bara Fapri, BSF Camp, PS- Bhaktinagar, Dist.- Jalpaiguri (v) Dipesh Gurung (36 yrs) S/O Dipak Gurung of Vill- Gurung Busty, PS- Pradhan Nagar, Dist.- Darjeeling and (vi) Krishna Subba (26 yrs) S/O Late Ganga Subba of Gurung Busty, PS- Pradhan Nagar, Dist.- Darjeeling and others 03/04 unknown miscreants and arrange for its investigation.


