Dear Sir,

I, Sri Amar Tirkey, Son of H.B. Tirkey, resident of Sisabari, Champasari, District-Darjeeling, driver by profession would like to inform you that on 16.03.2024 at around 2 p.m. while performing by duty as a driver to Sri Ashok Kumar Agarwal, Son of Late Jagadish Prasad Agarwal, resident of 2nd Mile, Sevoke Road, Siliguri, Post Office- Sevoke Road, Police Station-Bhaktinagar, PIN- 734001, West Bengal reached Sarkarpara near Tiranga More. My employer is the owner in possession of a plot of land situated at Sarkarpara near Tiranga More and further constructing a residential building over the said plot of land. After reaching the construction site my employer along with his wife got down from the vehicle and I went to park the car but as there was scotty parked on both the side of the road I came out of the car and was peacefully trying to shift the scotty. All of a sudden one Manish Raisaly, Son of Dew Kumar Raisaly who claimed to be the owner of the said scotty rushed towards me and started to assault him with fist, kicks and blow mercilessly and also abused me in filthy languages without any provocation whatsoever. I sustained grievous injuries at several places.

To the aforesaid fact, my employer Sri Ashok Kumar Agarwal also lodged a complaint before the Bhaktinagar Police Station on 16.03.2024 vide GDE No.760 dated 16.03.2024. Since, I was under doctor's treatment and in great pain I could not lodge this complaint before the authorities within due time. I therefore request you to take note of the aforesaid fact and take necessary action against Manish Raisaly and other unknown agents in accordance with law and oblige.
