Respected Sir,

With due respect, I Sri. Kailash Chandra Golwa, S/o. Sukhlal Golwa, resident of Upper M.G. Marg MW, Lal Market Road, Golwa Brothers, Gangtok Municipal Corporation, Gangtok, East Sikkim, Sikkim-737101 beg to state that I alongwith my mother, one sister & 5 brothers are the joint owners of total piece of land measuring about 12.5 Kathas, under R.S. Plot No. 6(Part), recorded in R.S. Khatian No. 90/1 more, situated within Mouza Dabgram, Sheet No. 6, Pargana Baikunthapur, Touzi No. 3, J.L. No. 2, P.S. Rajganj(Now Bhaktinagar), Dist. Jalpaiguri, W.B..

That some antisocial & landgrabbers have been trying to illegally trespass and capture our above mentioned land and on 14.02.2024 I have lodged a FIR in Bhaktinagar P.S. vide BKN GDE No. 823, dated 15.02.2024 in this respect and subsequently finding no other alternative, we have filed a civil suit against 1) PANKAJ PRASAD, 2)SHREE NATH PRASAD, 3) VISHAL KOTHARI (JAIN), in the Court of Ld. Civil Judge Junior Division 1<sup>st</sup> Court at Jalpaiguri being Title Suit No.111/2024 and on 20.02.2024, Ld. Court has passed an injunction order thereby directed both parties ted to maintain status quo over the suit property in respect of the nature, character and possession of the same as on day over the suit property till 21.03.2024 and on 21.03.2024 the order of Injunction was extended till 16.05.2024.

That on 24.02.2024 I have lodged FIR vide GDE No. 1331 dated 25.02.2024 for violating the Court order and with the assistance of police I could restrain them from illegally trying to make construction.

The above named PANKAJ PRASAD, & VISHAL KOTHARI (JAIN) have appeared the aforesaid case and they are well aware of the court order but Inspite of the Court's Order, they with the help of their men and persons have been trying to construct boundary wall and for that purpose they have been storing Bricks in our land disturbing for their illegal gain nad thereby violating the Ld. court order.
