Sir,

In producing herewith one accused person named Pankaj Roy @ Khotku (38yrs) S/O Kesta Mohan Roy of Pradhan para ward no 42 PS Bhaktinagar Dist Jalpaiguri under arrest along with following seized articles under proper seizure.viz

One multi colour nylon bag containing 10 (ten) bottles of Himalayan gold 60 up bottled by Himalayan endeavor PVT LTD West Bengal, each containing 600 ml total 6000 MI (6 liters), Rs 155/- each.

Sir

With due respect and humble submission, I SI Youel Lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS under Siliguri Police Commissionerate would like to lodge this written complaint against above noted Pankaj Roy @ Khotku (38yrs) S/O Kesta Mohan Roy of Pradhan para ward no 42 PS Bhaktinagar Dist Jalpaiguri to the effect that today on 24.03.2024 at about 16.05hrs i received a source information that one person is randomly selling liquor at Pradhan more under Bhaktinagar PS without any valid license.

Accordingly I informed the matter to the I/C PS and as per his kind direction I along with ASI Chandra Prakash Adhgikary, ASI Dipak Karmakar, C/374 Debraj Biswas had been to Pradhan more under Bhaktinagar PS to verify the veracity of source information.

At 16.45hrs we reached there and being identified by source we noticed that one person was selling illicit liquor at Pradhan more under Bhaktinagar PS. Subsequently, I along with my force cordoned the area and able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and recovered One multi colour nylon bag containing 10 (ten) bottles of Himalayan gold 60 up bottled by Himalayan endeavor PVT LTD West Bengal, each containing 600 ml total 6000 MI (6 liters)..On demand he failed to produce any valid license/papers for selling of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain.

Therefore I seized the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named Pankaj Roy @ Khotku (38yrs) S/O Kesta Mohan Roy of Pradhan para ward no 42 PS Bhaktinagar Dist Jalpaiguri under proper memo of arrest after observing all sorts of formalities at the spot. The whole process of seizure was made in between 16.55 hrs to 17.25hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Pankaj Roy @ Khotku (38yrs) S/O Kesta Mohan Roy of Pradhan para ward no 42 PS Bhaktinagar Dist Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
