**Subject: - F.I.R.**

Sir,

In producing herewith the seized articles viz one paper made cartoon containing 12 bottles of Old Monk Deluxe Rum each bottle containing 750 ml i.e. total (12 x 750 ml) = 09 ltrs marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1". I, SI Bandhan Roy of Pradhan Nagar PS, SPC would like to lodge this written complaint against accused person namely Kiran Chhetri (35 yrs) S/O Late Hem Bdr Chhetri of Mallaguri, near Hanuman Mandir, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that today on 25.03.2024 at 13.45 hrs I along with force left the PS to perform special RT mobile van duty vide Pradhan Nagar PS GDE No. 1475 , dated 25.03.2024. During my duty at 21.35 hrs I received a specific source information that one person stored huge quantity of illicit liquor without any valid license at his residence at Mallaguri near Hanuman Mandir under PS Pradhan Nagar, Dist. Darjeeling. Accordingly, I shared the information with you and as per your kind order and direction, I along with force conducted raid at the house of accused Kiran Chhetri of Mallaguri near Hanuman Mandir, PS- Pradhan Nagar, Dist. Darjeeling but seeing the police party he managed to fled away from the residence. On search the residence of the said accused recovered one paper made cartoon containing 12 (twelve) bottles of Old Monk Deluxe Rum each bottle containing 750 ml i.e. total (12 x 750 ml) = 09 ltr from his residence. I searched every possible corner to arrest the accused but found he is absconding. On enquiry it could be learnt that accused Kiran Chhetri (35 yrs) S/O Late Hem Bdr Chhetri of Mallaguri, near Hanuman Mandir, Ward No-45, PS- Pradhan Nagar, Dist.- Darjeeling stored the said illegal liquor at his residence without any valid documents with a view to sale the same in higher price for his wrongful gain. It is also learnt that the said accused Kiran Chhetri had been involved in selling liquor without any valid license for his illegal gain. Then, I seized and labelled the above-mentioned illegal illicit liquor under the proper seizure list and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1". The whole process of seizure and label was made in between 22.05 to 22.55 hrs at the spot for violating the norms of the Bengal Excise Act.

I, therefore pray before your good self that a specific case may kindly be initiated against accused namely Kiran Chhetri (35 yrs) S/O Late Hem Bdr Chhetri of Mallaguri, near Hanuman Mandir, Ward No-45, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
