Sir,

I'm producing herewith 01 (one) accused person namely Md Sagar (26 yrs) S/O Lt Md Mubarak of Matigara Biswas Colony, PS- Matigara, Dist.- Darjeeling under arrest and 01 automatic small fire arm (Pistol) measuring 20 cm in length with trigger, trigger guard, striking hammer, striking pin in working condition with 01 (one) round live .32 ammunition.

I, SI, Goutam Mallik of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the following arrested accused person namely Md Sagar (26 yrs) S/O Lt Md Mubarak of Matigara Biswas Colony, PS- Matigara, Dist.- Darjeeling. I beg to report that today i.e. on 26.03.24 at 17.15, I received a specific secret information that one person namely Md Sagar of Matigara Biswas Colony, PS- Matigara, Dist.- Darjeeling found moving at Siliguri Junction Bus Stand under PS- Pradhan Nagar, Dist- Darjeeling with one 01 automatic small fire arm loaded with live ammunition most probably for committing heinous crime at the locality. Accordingly, I diarized the information in General diary vide Pradhan Nagar PS GDE No 1527 dated 26.03.24 and informed the fact to you. As per your kind order and direction myself along with SI Bandhan Roy, ASI Biplab Kr Das C/1415 Chandan Basak and C/1416 Dilip Barman all of Pradhan Nagar PS left for Siliguri Junction under PS- Pradhan Nagar, Dist.- Darjeeling with investigation kit to work out the information by Govt. vehicle vide Pradhan Nagar PS GDE No 1528 and M.C.C No 759 dated 26.02.24. Under these circumstances any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant, the opportunity for the concealment of evidence or facility for his escape. At 17.45 hrs we arrived at Siliguri Junction and as indicated by the source we noticed that one person was moving suspiciously inside Siliguri Junction Bus Stand. Then, we cordoned the place from every corner with due care and caution. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we managed to apprehend him. On interrogation, he disclosed his identity as noted above. As per source information, he possessed 01 automatic small Fire arm (Pistol), hence, immediately I searched the said detained person and recovered 01 automatic small Fire arm (Pistol) loaded with 01 (one) round live ammunition which was kept concealed in his waist under his shirt. He exclusively possessed one automatic Fire arm loaded with ammunition illegally. On demand he failed to produce any document in support of the said automatic Fire arm (pistol) loaded with one live ammunition which was found in his possession. Thus, when his involvement in carrying and possessing illegal Fire arm and ammunition was established, I then seized the said automatic small Fire arm (Pistol) measuring 20 cm in length with trigger, trigger guard, striking hammer, striking pin in working condition and marked it as "Exhibit-A" and 01 (one) round live .32 ammunition marked as "Exhibit-B" under proper seizure list duly signed by the witness and acknowledge by the accused person. The search seizure and label were made in between 18.30 hrs to 19.25 hrs and subsequently arrested him by preparing memo of arrest informing him about the ground of his arrest.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Md Sagar (26 yrs) S/O Lt Md Mubarak of Matigara Biswas Colony, PS- Matigara, Dist.- Darjeeling is desperate and dangerous in nature, as he was carrying the said Fire arm loaded with ammunition with an objective to commit heinous crime in the locality.

As he wilfully violated the regulation of Arms Act, I, therefore pray before your good self that a specific case may kindly be initiated against the accused person namely Md Sagar (26 yrs) S/O Lt Md Mubarak of Matigara Biswas Colony, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation.
