Sri Pintu Kamti son of Manoj Kamti (Ram Sudiz Kamti) Resident of Old Matigara Road, Siliguri Junction, Gate bazar wanted to utilize our club for his personal use which was denied by our club president. At that time he threatened us and a F.I.R was lodged against him on dated 18.03.24 (copy enclosed).

Today i.e dated 26.03.24 at around 4.30 Pm near my house we were enjoying Holi Festival with our family member & friends, suddenly he came with his family near his house with his vehicle and started beating me when I escaped and ran to inside my house he along with brother Pappu Kamti, Mother Lalita Kamti and relative Rabi Das S/o Late Dulal Das he entered my house and started assaulting me. In the mean time my mother also came they also attacked my mother and injured her badly and also teased her. After few time police came and saved us. Further he also threatened that he will beat me once again.

I therefore request you to take necessary action
against him to stop any unfortunate event against
me and my family.
