Bhaktinagar, Dist - Jolpaiguri do hereby lodge this written complaint to the effect that that yesterday at about 06:30 P.M. near Battie company More, Ward No. 41, P.S. Bhaktinagar, Dist - Jolpaiguri one scuffle was taken place in between Manu Roy, S/o Late Simanta Roy and his wife namely Jute Roy both are the residents of Baikunthpally, Ward No. 41, P.O. Serake Road, P.S. Bhaktinagar, Dist - Jolpaiguri and Subhankar Barik @ Jugal Barik. Sir, it is to be mentioned here that the above mentioned accused were beating mercilessly to said Subhankar Barik by pressing the throats of Subhankar Barik and when I was passing through the road I noticed the same accused persons were beating mercilessly and I tried to stop them from such beating and assault. at that point of time the above mentioned Manu Roy started to assault me and not only this the above mentioned person touched my bodily parts with ill motive.
