I want to inform you that myself Manoj Kumar Singh S/o Shri Bishwadeo Singh was at Punch Hill view Dhaba & Resort, Around 8:30 Pm, ~~That~~ ^{That} time few people came in a group and start asking liquor from us, as me and my manager refused as we don't sell liquor they forcefully tried to snatch money from counter and demand 50,000/- (fifty thousand) from me and starting misbehaving and beating my manager, they broke the front glass and table alongwith other things which they got that time and we are heading towards our home they started stone pedling on our vehicle No. BR 11AD 3321 (Maruti Suzuki ciaz) Glass has broken and i got hit by them. After they told us that you have to pay gunda tax if you want to live here or want to business. All staff ran away due to fear of them.

Sir I am totally scared after this and inform immediately to pradhan Nagar Police Station last ~~with~~ night. and also ask help from Bhaktinagar Police Station as they are from Salugara and Gandhi Nagar.
