- 3) One iron made weapon called as 'Bhojali' 14 inches recovered from the conscious possession of Bikash Rai
- 4) One iron rod 14 inches recovered from the conscious possession of Bikram Paswan
- 5) One small torch light and rope approx 10 feet recovered from the conscious possession of Raj Kumar Nawar.
- 6) one iron rod (sabol) measuring 18 inches recovered from the conscious possession of Rahul Chhetri.

I, ASI Dipak Karmakar (8906402165) S/O Lt Dulal Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 1) Obaidur Rahaman (24yrs) S/O Safukul Sk of Gopinathpur, near masjid, PS Beldanga Dist Musrhidabad A/P Singaragadda, PS- Pradhan Nagar, Dist- Jalpaiguri (not verified), 2) Allaraka Sk (27yrs) S/O Lt Akshed Sk of Gopinathpur, near masjid PS Beldanga Dist Musrhidabad, A/P Singaragadda, PS- Pradhan Nagar, Dist- Jalpaiguri (not verified), 3) Bikash Rai (38yrs) S/O Ram Kumar Rai of Lower Bhanu Nagar near Kali Mandhir ward no 43 PS Bhaktinagar Dist Jalapaiguri, 4) Bikram Paswan @ Billu (27yrs) S/O Lt Dilip Paswan of Paswan Busty, Prakash nagar ward no 43 PS Bhaktinagar Dist Jalpaiguri, 5) Raj Kumar Nawar (33yrs) S/O Ram Kumar Nawar of Thana line near Police station Mirik, Dist Darjeeling, A/P Dada Bhai Colony, PS- Bhakti Nagar, Dist- Jalpaiguri 6) Rahul Chhetri (24yrs) S/O Lt Manoj Chhetri of Salugara BSF road PS Bhaktinagar Dist Jalpaiguri and 3/4 others to the effect that on 28.03.2024 at 00:15 hrs received a specific source information that 9/10 miscreants have assembled Chandal More near Gandhi Maidan under Bhakti Nagar PS, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity to the passerby in the area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarised the fact in General diary vide Bhakti Nagar PS GDE No 1432/24 dated 28.03.2024 and as per order I along with ASI Chandra Prakash Adhikari, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Chandal More near Gandhi Maidan under Bhakti Nagar PS, Dist.- Jalpaiguri to work out the information in hand.

At about 00.35 hrs we arrived at Chandal More near Gandhi Maidhan under Bhakti Nagar PS, Dist.- Jalpaiguri as indicated by the source we noticed that 09/10 persons assembled at Chandal More near Gandhi Maidhan under Bhakti Nagar PS, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after a hot chase managed to apprehended above noted 06 (six) of them with deadly weapons in their possession but 3/4 persons managed to fled away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that the following persons namely kalu, Imtiaz, and others were present there and making preparation for committing dacoity to the passerby in the area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 28/03/2024 in between 01.05 hrs and 01.45 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 06 (six) arrested accused persons namely 1) Obaidur Rahaman (24yrs) S/O Safukul Sk of Gopinathpur, near masjid PS Beldanga Dist Musrhidabad A/P Singaragadda, PS- Pradhan Nagar, Dist- Jalpaiguri (not verified), 2) Allaraka Sk (27yrs) S/O Lt Akshed Sk of Gopinathpur, near masjid PS Beldanga Dist Musrhidabad, Singaragadda, PS- Pradhan Nagar, Dist- Jalpaiguri (not verified), 3) Bikash Rai (38yrs) S/O Ram Kumar Rai of Lower Bhanu Nagar near Kali Mandhir ward no 43 PS Bhaktinagar Dist Jalapaiguri, 4) Bikram Paswan @ Billu (27yrs) S/O Lt Dilip Paswan of Paswan Busty, Prakash nagar ward no 43 PS Bhaktinagar Dist Jalpaiguri, 5) Raj Kumar Nawar (33yrs) S/O Ram Kumar Nawar of Thana line near Police station Mirik, Dist Darjeeling, A/P Dada Bhai Colony, PS- Bhakti Nagar, Dist- Jalpaiguri 6) Rahul Chhetri (24yrs) S/O Lt Manoj Chhetri of Salugara BSF road PS Bhaktinagar Dist Jalpaiguri and others kindly arrange for its investigation
