Sir,

With due respect, I beg to report that I ASI Nawaj Sarif, S/O- Sentu sk. presently posted at Siliguri PS/SPC do hereby producing two accused person namely (i) Uttam Paul, S/O- Late Rajendra Paul of Jalpaimore, w/n-05, PS- Siliguri, Dist- Darjeeling and (ii) Rajkumar Das, s/o- Ram Chandra Das of BI Ronodeep colony, PS- Matigara, Dist- Darjeeling and lodge this complaint against them. The brief fact is that, on 23.03.2024 at around 23:25 hrs in course of my night mobile Van duty (K-21 mobile van), when I along with my force performing the said detailed duty at Jalpaimore under Siliguri PS jurisdiction some unknown people, approx 5/6 person in intoxicated condition restrained our mobile van. When I along with force raised protest against them then they became furious and initially started calling some objectionable words and assault me physically and used vulgar languages, also threatened us in dire consequences. On being informed by one of the force named C/479 Dipak Chhetri of our mobile van another mobile van of our Police Station (K-22) arrived at the place. Finding another police van they fled away immediately though I managed to caught two of them (above mentioned) red handed and arrest them after proper arrest memo u/s- 41 CrPC.

Under these circumstances, I pray before you that, legal action may kindly be taken against the above noted accused persons and others for using criminal force to Police personnel in uniform, obstructing public servant and causing hurt to deter public servant discharging government duty.
