I, DIVYA GUPTA, D/o. Dinesh Prasad Gupta, r/o. Grace Homes Apartment, Tea Auction Road, Mallaguri, Siliguri, Dist.-Darjeeling would like to bring to your kind notice the following facts hereunder:

- That I am a law graduate and have been enrolled as a member of the Bar Council
 of West Bengal.
- 2. That around July, 2023 I came to be introduced to one person namely VISHAL CHAUHAN, S/o. Lakhbir Chauhan, r/o. Bengdubi Army Cantonment, Bengdubi, Dist.-Darjeeling on social media i.e. on Instagram having ID as "Vishal_chauhan101" and "vishal_chauhan015" and Facebook ID named as "ठाकुर विशाल चौहान(बजरंग दल)",

- 3. That since then we started chatting and also started video calling over several social media platforms and after some time me and the said VISHAL CHAUHAN got involved in love relationship and after that we also started meeting in person at various places in and around the city.
- 4. That as days passed the said VISHAL CHAUHAN started forcing me to involve in a physical relationship with him but every time I used to refuse to get involved in such relationships with him. It is very important to mention that whenever I used to refuse him to get involved in physical relationships with him he used to mentally torture me by using slangs and also to threaten me that if I did not get involve with him in a physical relationships he will do something bad to himself and for that I will be the only person to be blamed.
- 5. That after passing of 2-3 months the said VISHAL CHAUHAN took me to one farmstay situated at Muktikhola, Dudhia and there also he suddenly started forcing me to get involved in a physical relationship and also started threatening me that

he will kill himself if I do not have physical relationship with him and after that I was very much horrified as it was a very unknown place for me.

- 6. That on 18.11.2023 my mother expired and soon after that the said VISHAL CHAUHAN suddenly started behaving very strangely, he started abusing me over phone and threatening me that I should only talk to him otherwise I have to face bad consequences.
- 7. That as the acts and conducts of the said VISHAL CHAUHAN totally jeopardized my mental health I decided to end the relationship we had and soon after I discussed the same with him, the said VISHAL CHAUHAN started threatening him that he is having some indecent pictures and videos of mine and if I do not continue the relationship he will forward the same to my family members and will also post in all the social media platforms and not only he also started threatening my family members over phone calls made by him from several unknown numbers.

8. That most shockingly today from at around 11.30 AM my brother SRI DEEPAK GUPTA, started receiving messages and some indecent doctored images and videos of myself over WhatsApp from some unknown mobile numbers being 78303-39788, 95821-92125, 95685-52128 and also started threatening him with dire consequences. The desperate acts of the said VISHAL CHAUHAN went to such an extent that not only did he sent the aforesaid indecent pictures and videos to my brother but also he sent those images to my several family members and relatives from different unknown numbers.

So, I hereby requesting you to kindly take necessary legal actions against the said VISHAL CHAUHAN and arrange to take further necessary legal steps to stop spreading my aforesaid indecent images and videos in social media platforms and oblige.
