attention to the following effect that on 22/03/2024 at about 5:00 pm
my younger daughter Sneha Singh w/o Sri Satish Kr. Singh of lake town
Airahant Encliv (apartment) wd no .33 P.S N.J.P Dist. Jalpaiguri informed
me through phone that aforesaid NISHU DAS request my said daughter to
come their aforesaid residence on 22/03/2024 to take payment by way
cheque for which she went there house at 4 pm and after reaching my
daughter the aforesaid persons not only used to start harling filthy
languages towards my daughter but also mercilessly beat her and
aforesaid Nishu Das tried to kill her by Kinfe some how my daughter safe
her life but her finger was cut for which she sustain savior injury and
aforesaid Utaam das outrage the modesty of my daughter due to hue and
cry some local people assembled there and who restrain the aforesaid
person and my daughter somehow fled from there. I accordingly along
with my husband reached in the house of my daughter and took her in
Siliguri hospital for her treatment. The xerox paper of medical
prescription is annexed this complaint. It is to be noted that my said
daughter without informing her husband and also, me she transferred Rs-
4,00,000 (four lakh only) from her account of Canara Bank Being Account
-95302010037139 to the account of Nishu das and Rs- 100000 (one lakh
only) given in the hand of Uttam Das in cash because the aforesaid
persons induced my daughter to delivered the same. The aforesaid
persons paid Rs 2,22,000 out of Rs-500000. yesterday they asked my
daughter to come there to take a cheque amounting Rs-2,78,000 from
Nishu Das. The aforesaid persons are relative of us and they are Tring to
misappropriate the money of my daughter presently my said daughter is
seriously ill and suffering from anxiety trauma act. For which
unintentional; delay is appaired to lodge this complaint
So, I would like to request to take appropriate legal action as per law.
