Sir,

This is to bring to your kind notice that I, NARENDRA KUMAR PODDAR, son of Late Likhmi Chand Poddar, resident of Mayfair Garden, Palm View, Flat 2-A, Punjabipara, P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri, PIN-734001, am one of the partners of 'Jaisnavi Impex', a partnership firm, having registered office at H/67/631/453, Dr. Kalinath Road, Siliguri- 734005, P.O. and P.S. Siliguri, District-Darjeeling, GSTIN- 19AANFJ6244N1ZM, which is a reputed business organization dealing in the field of supplying Large Cardamom for more than 06(six) years having offices in different parts of Siliguri and my firm has earned goodwill for the said business for sincerely supplying Large Cardamom in various parts of India.

On 15.11.2022, Sri. Rajeshkumar Krushnmurari Gupta, proprietor of Sai Traders, having their registered office at 133/42 Dhakanapurwa, Goswami Nagar, Collectorganj, Kanpur Nagar, Kanpur, Uttar Pradesh, PIN-208001 and at Payagi Gali Mahant Shiwala, 0, Bharuhana, Mirzapur, Uttar Pradesh, PIN-231001, Mobile No: +91-8853199393/+91-8922904055, GSTIN- 09CEKPG5038N1Z0 placed an order for purchasing 500 kgs large cardamom of Rs. 2,83,250/- (Rupees Two lakh eighty-three thousand two hundred fifty only). Accordingly, I vide Invoice No. JI/118/2022-2023 dated 15.11.2022 sent large cardamom of Rs. 2,83,250/- (Rupees Two lakh eighty-three thousand two hundred fifty only) to him through the carrier 'Sikkim Logistics Services' vide e-Way Bill No. 881266656688 with the e-way bill dated 15.11.2022. Against such purchase he on 23.11.2022 made payment of Rs. 2,00,000/-(Rupees Two Lakhs) and thereafter placed another order for purchasing 1,000 kgs large cardamom of Rs. 5,00,000/- (Rupees Five Lakhs only). The same was duly dispatched/delivered vide Invoice No. JI/127/2022-2023 dated 24.11.2022 amounting to Rs. 5,00,000/- (Rupees Five Lakhs only), through the carrier 'Sikkim Logistics Services' vide e-Way Bill No. 851268682158 with the e-way bill dated 24.11.2022 and thereafter he made a payment of Rs.3,00,000/- (Rupees Three Lakhs only) dated 12.12.2022 to me/my firm and again placed another order for purchasing 1,200 kgs large cardamom of Rs.6,61,500/- (Rupees Six Lakhs Sixty-one Thousand and Five hundred only). The same was again duly dispatched/delivered to him vide Invoice No. JI/152/2022-2023 dated 15.12.2022 amounting to Rs. 6,61,500/- (Rupees Six Lakhs Sixty-one Thousand and Five hundred only), through the carrier 'Sikkim Logistics Services' vide e-Way Bill No. 871273603872 with the e-way bill dated 15.12.2022. Thereafter, on 28.12.2022, he made a payment of Rs. 2,83,250/- (Rupees Two Lakhs Eight-three Thousand Two Hundred and fifty only) to

me/my firm and further placed another order for purchasing 1,250 kgs large cardamom and 26 kgs CTC Tea amounting to Rs.6,61,732/- (Rupees Six Lakhs Sixty-one Thousand Seven Hundred and Thirty-two only). The same was one more time duly dispatched/delivered to him vide Invoice No. JI/167/2022-2023 dated 29.12.2022 amounting to Rs. 6,61,732/- (Rupees Six Lakhs Sixty-one Thousand Seven Hundred and Thirty-two only), through the carrier 'Sikkim Logistics Services' vide e-Way Bill No. 891276973116 with the e-way bill dated 29.12.2022 and there was still an amount of Rs.13,23,232/- (Rupees Thirteen Lakhs Twenty-three Thousand Two Hundred and Thirty-two only) due to me/my firm which he was supposed to pay. It is pertinent to mention here that as per such terms and conditions stipulated in the Invoices as aforementioned, he is legally liable to pay interest @24% per annum on the unpaid amount.

Furthermore, the bank details from which the initial payment was made to me are as follows- Account No.: 01800210002889, IFSC: UCBA0000180, Account Holder Name: SAI TRDAERS, Bank Name: UCO BANK.

I on several occasions reminded Sri. Rajeshkumar Krushnmurari Gupta over phone and various other modes of communication and demanded payment of the entire amount but he gave nothing to me instead of false assurances that he will make the payment. It is pertinent to mention here that even after sending him a mail with subject-"Reminder for overdue payment" at his Email- traderssai037@gmail.com on 22.07.2023 claiming the outstanding amount of Rs.14,83,232/- (Rupees Fourteen Lakhs Eighty-three Thousand Two Hundred and Thirty-two only), which included 24% interest, whereby he did not pay any heed to the said reminder.

Thereafter, I have also sent a Legal Notice through my duly engaged lawyer, Sri. Bapi Sarkar, on 18.12.2023, claiming Rs.16,12,317/- (Rupees Sixteen Lakhs Twelve Thousand Three Hundred and Seventeen only), which includes 24% interest till 30.11.2023, through a registered post, but he intentionally avoided receiving such Notice. Furthermore, he has also changed his phone number and no communication is possible over the phone now.

It is also pertinent to mention here that from the aforesaid acts and conducts of Sri. Rajeshkumar Krushnmurari Gupta, it is evident that from the very beginning he had an intention to deceive me and accordingly he fraudulently induced me to deliver large cardamom of huge quantities and amount on credit, initially made part payments of the Bills to build an element of trust and thereafter he converted it to his own use and he misappropriated the aforesaid amount for his unlawful gain causing financial loss to me/my firm, which amounts to criminal breach of trust and cheating.

Under the aforesaid facts and circumstances, I, the undersigned herein, request you to kindly investigate into the aforesaid incidents and take appropriate steps to punish Sri. Rajeshkumar Krushnmurari Gupta as per law.
