In Continuation to the above, it is to bring to your kind attention of an incident that occurred on 27th March 2024 on project road, involving a heavy vehicle transporting Floor Tiles weighing approximately 40-45 tons damaged newly constructed RCC drain severely.

The incident took place near Kisturi Warehouse Gate at Ch: 579+390 (RHS), where the said heavy vehicle caused significant damage to our roadside drain (Photographs enclosed for ready reference). The impact of the vehicle has resulted in visible harm to the infrastructure, impacting the functionality and integrity of the drain.

We kindly request your intervention in this matter to investigate the incident, assess the extent of the damage, and take necessary actions as per the law. The responsible party, should be held accountable for the damages caused.

Additionally, we would appreciate your guidance on the appropriate steps we need to take to ensure the prompt repair of the damaged roadside drain. Your cooperation and assistance in this regard will be highly valued.
