Darjeeling would like to inform you that I searched in facebook that facebook name Anjali Gurung are given vacancy of their company M/S Maa Tara Asset Reconstruction and consultancy services . Their main office situated at 114/3 Raja SC Mullick Road, Kolkata – 700084 and their Branch office situated at Milan Pally, Children Park, Siliguri and the shop name is Maa Tara Recovery and Finance Company. I visited at Maa Tara Recovery and Finance Company . Mr Shyamal and Boni had taken interview of me. They are the partner. They Demand Rs. 3500.00 from me for given percentage of my works. I had given cash Rs. 3500.00 . He gave me one joining letter. There mobile number is 7363927711 (Boni), 6289676797(Shyamal) After next two or three days they demand 20,000.00 which was refundable for their some work. After seven days on dated 01.03.2024 they demand Rs. 50,000.00 and told me they refund the amount with interest. They refund on same days 10.000.00 I collect the money Rs. 50,000.00 from outside with 20% interest. They told all the money they will return within seven days. On 13.03.2024 they called me and told me that they need more 20,000 for some purpose. I had taken the amount from outside with interest. In this way they convinced me and taken total Rs. 83500.00 an interest 12000.00. Now all the borrower demanded money from me and they closed the shop and fled away and did not response from phone. Actually today they are given a date to refund money.

So Sir, I therefore request you to take necessary action and lodge FIR against them.
