Respected Sir,

With due respect, I, Dr. Krishna Chandra Sarkar, Son of Late Narayan Chandra Sarkar, resident of Kabiguru Sarani, Near Rathkhola Maidan, Subhash Pally, Ward No. 22 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Siliguri, Pin No. 734006, District Darjeeling, beg to state that I along with my wife namely Smt. Shilpi Sarkar, are joint owners of a piece and parcel of Bastu vacant land measuring 2 Katha 4 Chhatak, appertaining to R.S. Plot No. 11514, corresponding to L.R. Plot No. 4057, recorded in R.S. Khatian No. 3326/1, corresponding to L.R. Khatian Nos. 11755, 11756, 11757 & 11758, Situated within Mouza Siliguri now Siliguri Purba, Hakimpara, within the jurisdiction of Police Station Siliguri, District Darjeeling, by virtue of a registered Deed of Sale being No. I-1198 for the year 2023 executed by Goutam Krishna Paul & 3 Others. After purchasing the said land we have been enjoying, possessing our aforesaid land without any objection, interruption whatsoever by constructing brick wall and iron-gate in and around our aforesaid land.

It is pertinent to be mentioned here that the previous land owners namely Goutam Krishna Paul & 3 Others have filed a civil Suit in respect of the above mentioned land against one Ratan Das & others and the same suit was decreed and the Ld. Court passed decree that Goutam Krishna Paul & 3 others from whom we purchased the above mentioned land are the absolute owners having right, title, interest and possession and also passed a permanent order of injunction and thereby restrained Ratan Das & Others from entering into the said land.

Today in the morning I came to learn that a portion of brick wall in the Eastern side of the land has been demolished by some unknown miscreants and upon entering into the boundary I found that our Pipes, Tin, Iron Rods which we stored there for construction of building are missing from our aforesaid land. That the unknown miscreants with the intention of theft and causing damage to our property has entered into our land in our absence and fled away after taking Pipes, Tin, Iron Rods and damaged of brick wall in the Eastern side.

Therefore I request you to investigate the matter and take strict action against those miscreants for which I shall be forever obliged to you.
