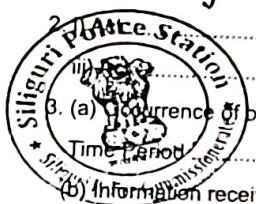

Early action in this regards would be highly appreciated.


