That on 25/03/2024 - at about 6:00pm to 6:30pm, my minor daughter said me that she is going to the shop located nearby in this locality and ever since then she is missing and nobody could find her anywhere. That out of curiosity and suspicion I believe that a girl name Sonu Das, aged about 24 years, o/w - Dipu Das, resident of Dabgoam, Near Matrisadam Hospital, Siliguri has manipulated and taken our minor daughter without proper knowledge of my minor daughter.
