**Sub: Breaking into and trespass of our premise and attempted theft of electric meter No. HE0146908**

Sir,

I, Sri Umesh Lama, S/o. Jit Bahadur Lama, one of the Directors of Tarai Foundry Works Pvt. Ltd., a company registered under the Companies Act 1956, having its registered office at Siliguri Industrial Estate, Plot No. 10, 2<sup>nd</sup> Mile, Sevoke Road, Siliguri – 734001, Police Station – Bhaktinagar, District – Jalpaiguri, beg to lodge this complaint as under:

1. That there is an electric connection vide Consumer ID No. 400925998 in our godown situated at Kanchanjungha Complex, within Ward No. 42 of Siliguri Municipal Corporation at Salugara, Sevoke Road, Siliguri.
2. That on 18-03-2024, a new meter vide meter no. HE0146908 was installed in the above mentioned premise by the Power House CCC, W.B.S.E.D.C.L. while in the presence of our caretaker Sri Guddu Yadav, S/o. Chandradev Yadav.
3. That today (30-03-2024) at around about 12.00 hrs, when Sri Guddu Yadav was walking back to his residence, he noticed that the abovementioned meter being hurdled over from inside the boundary-wall while it was still connected by wire to the nearest electricity pole. As such, he stopped to investigate and found the broken lock on the gate of the premise. Sometime later Sri Guddu Yadav watched as Sri Saiyam Goyal, S/o Late Ramesh Goyal, residing at Neelkamal Apartment, Pranami Mandir Road, Sevoke Road, Siliguri, along with 02 (Two) other associates exit from the premise gates. It can be reasonably inferred that Sri Saiyam Goyal and his goons broke the lock of the godown gate, unlawfully entered the premise therein and removed the said electric meter from its installed location.
4. That Sri Guddu Yadav confronted them and tried to stop them from fleeing the scene along with the misappropriated electricity meter which was still lying on the ground underneath the electricity pole after being hurdled over the wall. They verbally abused and threatened to beat him before hurriedly entering a white 4-wheeler, that was parked nearby to the gate with a driver inside the vehicle, and escaping the scene.


