Respected Sir,

I hope this letter find you in good health. I am writing to bring to your attention a recent incident that took place at our residence in SONY RESIDENTS, Deshbandhupara, Siliguri. It is with a great disappointment that I inform you about the vandalism of a CCTV camera installed on the roof and the subsequent theft of valuable household items mainly costly ceramic flower pots and broke the lock of main door of beat of maid.

It has come to my knowledge that this act of mischief was perpetrated by the miscreants associated with Mr. Bablu Banerjee and his family, residing in the same apartment. It is important to note that Mr. Bablu Banerjee and his family have a history of anti social activities as evidenced by their previous cases in several police stations and their imprisonment for an extended period.

We discovered that the CCTV camera installed on the roof had been deliberately broken. The camera which served as a critical security measure for our residence, has been rendered useless. Due to this act of vandalism, our utmost distress, the incident of camera sabotage was followed by the theft of several household materials, primarily costly ceramic flower pots. These items held not only monetary value but also sentimental significance to our family. Given Mr. Banerjee's known anti social background and his family's involvement, we strongly suspect their role in this outrageous act.

Hence, as a precautionary measure and safety, I request your kind honour to consider this application as a General Diary and if further such incidence occurs, kindly take necessary measures as further records and documentations.
