I Somraj Mukherjee S/o Lt Swapan Kumar Mukherjee resident of Hakimpara Siliguri would like to inform you that on 25-03-2024 I was going to my business location at Porajhar, Satellite Township at around 4:50 pm. On the way 4 drunk boys blocked the road. I was with my business partner and when we asked to give space they used slang language. We got out of our car and more boys gathered and started hitting us. Most was in drunk condition. One of them struck a stone on my maruti A16 LXI (10B74 AX5653) and broke the back glass. Some one out of the gang tried to snatch my two Gold chain and managed to pull one chain. The cost of the Gold Chain is about 1.5 Lacs

I have managed to get some names of out of the group. The names of the attackers are ① Karan Mahato S/o Dukha Mahato ② Gopal Mahato S/o Ranglal Mahato ③ Suraj Mahato S/o Kun Kun Maha There were more 7 to 8 people with them. All are resident of Porajhar.
