Sir,

In producing herewith three (03) arrested accused persons namely (1) Amit Balmiki (32) S/o Lt. Rotas Balmiki of Champasari Dhaknikata PS Pradhan nagar Dist. Darjeeling (2) Md Aktar (32) S/o Maja Mahammad of Mallaguri , Ratanlal Busty , Ward No. 1 PS Pradhan nagar Dist. Darjeeling and (3) Bapi Singh (38) S/o Lt. Gopal Singh of Darivit , Bihari Busty, PS Islampur Dist. Uttar Dinajpur along with following seized articles viz,

1. One Blue colour luggage bag having styled "adidas" containing two packet said to be Ganja wrapped with black colour plastic and again white colour plastic tide with cello tape approx weighing (10.350 + 10.100) total approx 20.450 kgs , Marked as Exhibit- A in which Exhibit- A1 & A2 were recovered from the possession of accused Amit Balmiki.
2. One Blue & white colour check luggage bag having containing two packet said to be Ganja wrapped with black colour plastic and again white colour plastic tide with cello tape approx weighing (10.300 + 10.300) total approx 20.600 kgs , Marked as Exhibit- B in which Exhibit- B1 & B2 were recovered from the possession of accused person Md Akter.
3. One Blue & Red colour check luggage bag having containing two packet said to be Ganja wrapped with black colour plastic and again white colour plastic tide with cello tape approx weighing (10.400 + 10.600) total approx 21kgs , Marked as Exhibit- C in which Exhibit- C1 & C2 were recovered from the possession of accused person Bapi Singh.
4. One key pad mobile phone model "Lava" black colour, having IMEI No-(i) 350996952024912 (ii) 350996952024920, Sim connection No. 7478121439 from the possession accused Bapi Singh.

I, SI Tanmay Kundu of NJP PS, Siliguri Police Commissionerate do here by lodged this complaint against (1) Amit Balmiki (32) S/o Lt. Rotas Balmiki of Champasari Dhaknikata PS Pradhan nagar Dist. Darjeeling (2) Md Aktar (32) S/o Maja Mahammad of Mallaguri , Ratanlal Busty , Ward No. 1 PS Pradhan nagar Dist. Darjeeling , and (3) Bapi Singh (38) S/o Lt. Gopal Singh of Darivit , Bihari Busty, PS Islampur Dist. Uttar Dinajpur to the effect that on 27.03.24 at about 17-50 hrs I received a secret source of information that three persons were standing near Mahananda Bridge at Porajhar More under NJP PS with huge quantity of Ganja for clandestinely disposal of the same illegally. Accordingly I informed the matter to the duty officer and O.C PS which was diarized vide NJP PS GDE No- 1420 dt- 27.03.24. Thereafter as per his instruction myself along with SI Debabrata Khan, ASI Khagen Barman, ASI Dhruva Mishra ,C/152 Abdul Kayum Miah C/1462 Sajan Tamang, VP/13 Jamirul Islam CV/297 Putul Roy with mobile Van officer ASI Amal Debnath and force left for the spot to verify the veracity of the information vide corresponding NJP PS G.D.E. No. 1421 dtd 27.03.24 and NJP PS M.C.C No- 1021/24 Dt.27.03.24.

At the time of departure from the Police Station I bring a spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal, emergency light etc. On arrival at about 18-20 hrs at Porajhar More under NJP PS by Govt. vehicle bearing No. WB-77-4092, we found three persons were standing there with three luggage bags in a suspicious manner and on being identified by the source we tried to apprehend them, but seeing the police team they tried to flee away with their bags from there and on hot chase we somehow managed to detain them. In the meantime near the said place I called two independent witnesses namely (1) Sujit Saha (28) S/o Lt. Paresh Saha of Porajhar, PO Satelite Town ship PS NJP Dist. Jalpaiguri and (2) Sanjay Sarkar (29) S/o Shankar Sarkar of Porajhar, PO Satelite Town ship PS NJP Dist. Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. On being asked , the apprehended persons disclosed their name and identity as noted above which are not verified as on spot they could not produce any documents in support of their identity. After disclosing our identity I asked them whether they wanted to be searched themselves in presence of an Executive Magistrate or any Gazetted Officer as we have information the apprehended

persons were carrying huge quantities of Ganja and they agreed to search by any one. I also served them an option notice in accordance with the provisions of law in this regard in writing and they also gave their approval of being searched by any one in writing in the notice served to them. Accordingly I informed the matter to O.C. NJP PS and he informed me over mobile phone to send one requisition to Sri Somnath Das ,ACP, East-II, SPC as he is detailed for special executive magistrate for this date as no other magistrate was available at that time. Accordingly I informed Sri Somnath Das ,ACP, East-II, SPC and requested him to come to the spot through one special messenger namely C/152 Abdul kayum Miah by one motorcycle bearing No. WB-86-0650 at his office at Teenbatti More, Siliguri. At about 19-35 hrs Sri Somnath Das ,ACP, East-II, SPC and O.C. NJP PS arrived at the spot and I disclosed the identity of Sri Somnath Das ,ACP, East-II, SPC as a Gazetted officer to the accused persons and also to the witnesses. I also offered the independent witnesses and the accused persons to search our Police Party as per provision of law. But they refused to search the police party. Under the supervision of Sri Somnath Das ,ACP, East-II, SPC and in presence of independent witnesses I with the help of other police officers conducted searched and recovered three luggage bag in contents six packets Ganja, two packets in each bags wrapped with black colour plastic packet and again white colour plastic from their join possession of the above noted accused persons which they were carrying. On demand in presence of the Gazetted Officer Sri Somnath Das ,ACP, East-II, SPC the apprehended person failed to produce any valid documents in support of possessing the same.

I accordingly weighed the recovered said to be Ganja by the weighing instrument and seized the same as per proper seizure list as mentioned above from the exclusive possession of the apprehended persons and labeled and sealed all the articles in presence of Sri Somnath Das ,ACP, East-II, SPC and independent witnesses and accused persons, duly signed by them and the Gazetted officer Sri Somnath Das ,ACP, East-II, SPC and acknowledged by the accused persons. On further asked the apprehend persons confessed their guilt in presence of Gazetted Officer Sri Somnath Das ,ACP, East-II, SPC and other witnesses that they procured the said Ganja clandestinely from Jalpaiguri side and got down from Bus at Noukaghat More and thereafter they waited at Porajhar More near Noukaghat More for Bihar bound Bus for the purpose of selling the same to their designated customers at Islampur side and Bihar side and after in order to earn huge money illegally. Then I arrested the above noted three accused persons u/s- 41 CrPC after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest .The copy of seizure list and Memo of Arrest has been supplied to above noted accused persons under proper receipt as the accused persons violated the terms and condition of NDPS Act. The seizure and arrest was made between 19-55 hrs to 21-30 hrs.



Darjeeling and (3) Bapi Singh (38) S/o Lt. Gopal Singh of Darivit , Bihari Busty, PS Islampur Dist. Uttar Dinajpurand arranged for its investigation.
