Respected Sir,

With due regards, I, SMT. PALLABI BARMAN, Wife of Sri Kaneswar Barman, Daughter of Sri Paresw Barman, Presently residing at C/O Nital Goswami, Nabagram, Sukanta Sarani, Ward No.33, P.O. Bhaktinagar, P.S. N.J.P., District Jalpaiguri, would like to lodge this written complaint to the effect that Sri Kaneswar Barman, Son of Praneswar Barman, Vill – East Khaterbari, Hazra Hat-II, Cooch Behar, Khaterbari South, Cooch Behar, West Bengal, Pin-736146, and our marriage was solemnized on 13.03.2020 according to the provision of Hindu Marriage Act, 1955 and thereafter, social marriage ceremony was performed on consent of both the family members. It is to be mentioned here that our marriage was the outcome of our previous love and affairs and when the marriage was took place, I was only 21 years old. After marriage, my husband brought me at my matrimonial house at Vill – East Khaterbari, Hazra Hat-II, Cooch Behar, where we started to live and cohabited together as husband and wife and in my matrimonial house, besides ourselves, my parents-in-law, and his family members also used to reside there. After marriage, we have passed our martial life happily for a period of six months and immediately after elapse of six months, I have noticed some abnormal attitude and behavior of my husband and other in laws members. My husband used to consume alcohol almost everyday and he is a habitual drunker and used to come home in the midnight or late hours and I have no right to ask him about anything as to why he is coming late and consume alcohol. My in laws. members known everything about the attitude, behavior and alcoholic habit of my husband but they never make any protest against such type of behavior of my husband and if I raised objection against such type of illegal acts and behavior, he did not bother to assault me physically and also abused me with filthy and abusive languages. My husband always insisted me to bring a sum of Rs. 4,00,000/- only from my father as our marriage was the outcome of our love affairs and told me that if my father organized a social marriage ceremony, at least a sum of Rs. 4,00,000/- only will be required and over this issue, he always created pressure upon me to bring the said amount from my father and when I refused to agree with his said proposal to bring the said amount from my father, he used to assault me mercilessly. In spite of the aforesaid torture of my husband, I used to borne all such type of torture of my husband with a hope that in near future he will definitely realize his own mistake and thereby rectify himself but all my hopes have gone in vain due to the continuous torture of my husband. Day by day, he increased his torture upon me both physically and mentally and treated me just like a maid servant. He always threatened me not to keep any contact with my familymembers or the neighbours of my matrimonial house.

Since the date of marriage, I have requested my husband for family planning but he was less interested over this matter and after two years of our marriage, became pregnant and gave birth a male child on 22.02.2022 at Creation the Fertility Centre, Burdwan Road, Silliguri whose name is Master Ritwick Barman. My husband is a man of bad character having maintaining illicit relation with so many women and after the birth
