In producing herewith four (4) accused persons namely 1. Subal Roy (24) S/o Suresh Roy of Baribhasa , near Ata Mill PS NJP Dist. Jalpaiguri (2) Apan Das (28) S/o Mistu Das of Sahudangi, Paglupara Hatat Colony PS Bhorer Alo Dist. Jalpaiguri (3) Sontosh Das (20) S/o Biren Das of Baribhasa , near Ata Mill PS NJP Dist. Jalpaiguri (4) Chattu Roy @ Chima (34) S/o Lt. Mithu Roy of Haripur Nich para PS NJP Dist. Jalpaiguri along with seized articles viz

1. One Iron rod having length approx 2 ½ feet from the possession of accused person Subal Roy.
2. One Iron made " Bhojali" measuring approx 15 " Inches including butt from the possession of accused Apan Das.
3. One iron made "Sabol" length approx 3 feet from the possession of accused person Sontosh Das.
4. One Knife having length approx 10" Inches including butt from the possession of accused Chhattu Roy
5. One Electronic torch light from the PO.
6. Two special Cigaretate open packets In containing 15 pcs Cigaretate from the PO.

I SI Binup Mahato of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 6/7 persons to the effect that on the night 30.03.24 at 00-35 hrs received secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at Ghora More under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 1543 dt. 30.03.24 . As per your kind direction myself alongwith ASI Dhruba Mishra, ASI Khagen Barman, C/152 Abdul Kyum Miah C/1462 Sajam Tamang, CV-297 Putul Roy, CV-306 Biswajit Roy left from PS for Ghora More to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 01-05 hrs and stopped out vehicle at a considerable distance from that place and we started walking towards the said place and we reached near Ghora More, found a group of 10/11 persons assemble and gossiping in a dark place at Ghora More under NJP PS. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the 04 (four) persons noted above and the others 6/7 persons managed to flee away from the spot . On interrogation they disclosed their identity which not verified and they also stated that they alongwith their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Ghora under NJP PS. Thereafter all the apprehended persons were searched and due to late night could not found any independent witness to present at the time of search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them. Accordingly I arrested the above noted accused persons u/s 41 Cr.P.C. The seizure and arrest made in between 02-05 hrs to 03-35 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against the 04 ( four ) accused person namely 1. Subal Roy (24) S/o Suresh Roy of Baribhasa , near Ata Mill PS NJP Dist. Jalpaiguri (2) Apan Das (28) S/o Mistu Das of Sahudangi, Paglupara Hatat Colony PS Bhorer Alo Dist. Jalpaiguri (3) Sontosh Das (20) S/o Biren Das of Baribhasa , near Ata Mill PS NJP Dist. Jalpaiguri (4) Chattu Roy @ Chima (34) S/o Lt. Muthu Roy of Haripur Nich para PS NJP Dist. Jalpaiguri and 6/7 other persons and arranged for its investigation.
