I, Smt. Tara Roy, Wife of Dulal Roy, Matigara, Motajote, P.O. & P.S. Matigara,  
Dist. Darjeeling, do hereby solemnly affirm and declare as follows:-

1. That on 26.3.2024 at about 7 p.m. (i) **Josheph Bag**, Son of Gabriel Bag, (ii) **Munmun Barman**, Wife Chandi Barman, (iii) **Amri Barman**, Son of Upashu Barman (iv) **Sruti Barman**, D/O. Upashu Barman, (v) **Smt. Niva Munda**, Wife of Ninku Munda, (vi) **Bulti Munda**, Wife of Bablu Munda, (vii) **Prabin Barman**, Son of not known all are resident of Matigara, Motajote, P.O. & P.S. Matigara, Dist. Darjeeling, and (viii) **Bondhu Munda**, Son of not known, (ix) **Sivani Munda**, Wife of Bondhu Munda (relatives of above five persons), all of suden entered into my house and started abusing us with filthy and insulting languages, when we tried to pacify them at that time the above named accused persons starting assaulting me and my two daughters and my son and my husband, they brutally assaulted us like animals, seeing the situation when we cannot tried to handle them we raise hue and cry and hearing hue and cry para people gathered in our house and save us from their clutches finding no other alternative they went to their house but before that they threatened us that they would again come and that time the would burnt us with our house alive.

It, is to be mentioned here that all the above named accused persons on the instigation of Josheph Bag, son of Gabriel Bag entered in our house and assaulted us brutally and ransacked our all house hold articles.

Said Josheph Bag and Prabin Barman since beginning tried to encroach our land by threatening us, he told that the land and house on which we reside belong to him and we have to vacate the land and house and for this purpose they already lodged false complaint against us earlier also.

2. That yesterday i.e. on 27.3. 2024 since morning at about 9 a.m. the above named accused persons on the instigation of the accused Joseph Bag and Prabin Barman came and told us to vacate our house and throw our household articles and when we retrained at that time said Joseph Bag put knife on my neck and told that he would kill her if we do not listen them and when my husband, son and daughter came to save me at that time they started assaulting us in the said scuffling my elder daughter got injury on her abdomen and little finger of her right hand, my husband got injury on his right shoulder. Said Amri Barman and Bondhu Munda badly touched my elder daughter namely Chanda Gowala private organs and tore her wearing apparels , they out raged her modesty, the above named accused persons again came at our residence at about 7 p.m. and started brutally assaulted my son Ashok Gowala and he got serious bleeding injury under his right elbow and thereafter, they snatched my silver made neck chain and my husband's watch and fled away from there threatening that they would at any cost throw us out from our house.

I, therefore, request you to kindly take necessary legal action in the aforesaid matter against the aforesaid persons.
