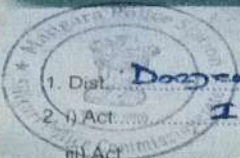

MALLICK, w/o. Raja Mallik and ⑥ MAYA MALLICK,
w/o. Lt. Mahabir Mallik, all are resident of
Vill. Kalanjote, P.S. Maligara, Dist. Darjeeling, in
drunken condition, brutally assaulted my minor
daughter and minor son and my husband
suddenly after entering our room by saying
them to leave your house and hand over to us.
