
With due respect, I am producing herewith 01 (one) arrested accused person named Pradip Roy @ Tepu, S/o- Bipul Roy of B. Ed. College Para, Shibmandir, PS- Matigara, Dist- Darjeeling under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 10 (ten) bottles of Himalayan Gold Country Spirit 60 UP (each bottle containing 600 ml and 6 ltrs in total).

I, SI Shib Sankar Das, presently attached with Matigara PS, SPC under your kind control beg to state that on 02.04.24 during evening mobile van duty vide MTG PS GDE No. 110, Dated- 02.04.24, at about 20.15 hrs, I received a secret source information that one person as noted above is selling ID liquor illegally from his house located at B. Ed. College Para, Shibmandir, PS- Matigara, Dist- Darjeeling. Accordingly, I inform the matter to you and as per your kind direction, myself along with C/868 Sujal Roy, C/219 Sanatan Chitrakar all of Matigara PS, SPC left PS for B. Ed. College Para, Shibmandir under Matigara PS to work out the information in hand. At about 20.35 hrs we arrived at B. Ed. College Para, Shibmandir in the house of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling ID liquor from his house. On being asked he disclosed his name and address as noted above. During raid, the persons who were buying liquor were able to flee away from the house of the accused person. During interrogation he disclosed that he is selling ID liquor from his house located at B. Ed. College Para, Shibmandir, PS- Matigara, Dist- Darjeeling for his illegal gain. On being search his house, the above noted I/D liquor were recovered. On demand he failed to produce any documents/license in respect of store/sale of the I/D liquor which were recovered from his house. Accordingly, I seized the above noted I/D liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure, label & arrest was made in between 20.45 hrs to 21.15 hrs on 02.04.2024.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused named Pradip Roy @ Tepu, S/o- Bipul Roy of B. Ed. College Para, Shibmandir, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
