Sir,

With due respect, I, SI Goutam Mallik of Pradhan Nagar Police Station under Siliguri Police Commissionerate producing the herewith the seized articles viz :- one paper made carton containing 29 bottles of 70 UP INDIA MADE LIQUOR "KACHI" containing 300 ml in each bottle and marked as Exhibit "A" and one bottle of the same taken as sample for examination and marked as Exhibit "A-1" i.e. total (30 x 300 ml) = 09 ltrs. and would like to lodge this written complaint against one accused namely Lily Gurung (F/41) W/O Kul Bahadur Guring of Salbari Bazar, PS. Pradhan Nagar, Dist. Darjeeling to the effect that on 04.04.24 at 21.05 hrs I received a specific source information that the one lady of Salbari Bazar under Pradhan Nagar, Dist.- Darjeeling is selling and storing huge quantity of illicit liquor at her tea stole situated at Salbari Bazar. Accordingly, I diarized the fact in General Diary vide Pradhan Nagar PS GDE No. 229 dated 04.04.2024 and informed the matter you.

As per your kind order and direction, I along with SI Bandhan Roy, ASI Biplab Kr Das, LASI Tania Roy, LASI Mithu Kabiraj, C/1411 Ashok Roy, LC/1263 Sujata Thapa all of Pradhan Nagar PS left for Salbari Bazar under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information. On reaching there and as identified by the source, I along with other officers, lady officers and force conducted raid at the tea stall situated at Salbari Bazar, PS- Pradhan Nagar, Dist.- Darjeeling but seeing the Police party the owner of the said Tea stall managed to fled away from the tea stall. We tried to apprehend her but in vain. On search 30 (thirty) bottles of 70 UP INDIA MADE LIQUOR KACHI containing 300 ml in each bottle recovered from the said tea stall which was kept in a paper made carton. During enquiry it could be learnt that the owner of the said tea stall namely Lily Gurung (F/41) W/O Kul Bahadur Guring of Salbari Bazar, PS. Pradhan Nagar, Dist. Darjeeling is running such type of illegal business of selling illicit liquor at her tea stall since long for her wrongful gain. Accordingly, I seized the same under proper seizure list in presence of available witnesses and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1". The whole process of seizure and label has been made in between 21.50 hrs to 22.30 hrs at the spot.

Therefore, I pray before your good self that a specific case may kindly be initiated against accused Lily Gurung (F/41) W/O Kul Bahadur Guring of Salbari Bazar, PS. Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
