That there are 12 nos. of teak & gamari trees in the below schedule land and I have taken permission from the Range Officer, Bagdogra Forest Range, Kurseong Division to cut the said trees on 29-03-2024. Today i.e. on 04-04-2024 at about 12.30 P.M. when I sent my workers & labours to cut the trees with tree cutting equipments two (2) persons namely (1) Chandra Shekhar Choudhary, S/o. Unknown, & (2) Sachin Kumar Choudhary, S/o. Chandra Shekhar Choudhary, R/o. Bhujabani, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal objected & physically assaulted my labours and threatened them not to cut the trees from the below schedule land. Both of them entered my land with hasua & dau and started threatening my labours to stop the cutting the trees or else they will kill them. Then & there my labours stopped their works & they informed me the matter.
5. That (1) Chandra Shekhar Choudhary, & (2) Sachin Kumar Choudhary are antisocial elements & land grabbers of the locality they are trying to grab my land by hook or by crook. I have invested a lot of money to develop the land & now because of (1) Chandra Shekhar Choudhary, & (2) Sachin Kumar Choudhary I am facing problem everyday. The main intension of (1) Chandra Shekhar Choudhary, & (2) Sachin Kumar Choudhary are to grab the land by hook or by crook by using muscle power.


