Sir,

In producing herewith the 01 (One) arrested accused person named Mithun Ramchandra Mahato of Bidhanpally, Ward No. 10, PS- Dalkhola, Dist- Uttar Dinajpur along with the following seized articles under proper seizure list :-

- (i) One Plastic transparent packet containing 469 (four hundred sixty nine) grams suspected to be Brown Sugar covered with a black colour plastic bag.
- (ii) One Hero I-Tel keypad mobile phone (Blue) having Airtel SIM No. 8991000920689744770U and bearing IMEI No. 351374671840621 and 351374671840639 .
- (iii) One cotton bag marked as 'Super Dresses'.
- (iv) One used red and white colour handkerchief.
- (v) One 'Balwan' marked tombaku packet.

I, PSI Avijit Banik, S/O- Animesh Banik of Matigara Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted 01 (One) arrested accused person to the effect that today 06.04.2024 at about 16.15 hrs, I received a specific source input that one person coming from Malda side towards Siliguri side with huge consignment of suspected to be Brown Sugar for his clandestine disposal. The matter was diarized vide Matigara PS GDE No. 332, Dt. 06.04.2024 and I informed the matter to the I/C, Matigara PS, SPC and expressed the entire information. As per his kind direction at 16.25 hrs on 06.04.2024 myself along with other officers and force named ASI Dharendra Nath Mandal, ASI Pema Dorjee Sherpa, C/868 Sujal Roy, C/219 Sanatan Chitrakar all are of Matigara PS, Siliguri Police Commissionerate being headed by me left for Phansidewa More Under Pass, under Matigara PS, SPC by govt. vehicle with investigation kit to verify the veracity of the information in hand vide Matigara PS GDE No 333, Dated- 06.04.2024 and M.C.C. No. 516/24, Dated- 06.04.2024. I also informed the Videographer namely Somnath Chatarjee, S/o- Sushil Chatarjee of Aurobindo Nagar, W/No. 22, PS- Siliguri, Dist- Darjeeling to be present at Phansidewa More Under Pass, under Matigara PS, SPC to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 16.35 hrs we arrived at Phansidewa More Under Pass, under Matigara PS, SPC. After reaching at the spot, I called two independent witnesses namely (i) Shri Hari Barman, S/o- Lt. Haren Barman of Pramod Nagar, PO- New Rangia, PS- Matigara, Dist- Darjeeling and (ii) Shri Ratan Paul, S/o- Lt. Narayan Paul of Paul Para, PS- Matigara, Dist- Darjeeling and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as independent witnesses under relevant provision of law. In the mean time at about 17.10 hrs, identified by the source, I saw that one person was loitering near to Phansidewa More under Pass with a bag in his hand. Accordingly, I apprehended the said person and disclosed our identity with a strong reason to believe that he illegally possessing suspected to be Brown Sugar for his clandestine disposal the same to Matigara PS area for his wrongful gain. On being asked, he disclosed his identity as noted above (not verified). Then, I sent C/868 Sujal Roy with a requisition to the office of the ACP (SB), SPC to supervise the search & seizure and act as an Special Executive Magistrate if required. At about 18.15 hrs on 06.04.2024, C/868 Sujal Roy came to the spot with Shri Shyam Prasad Saha, WBPS, ACP (SB), Special Executive Magistrate, SPC.
