Sir,

I, SI Binup Mahato of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Dulal Roy (59yrs) S/O Lt. Bhogchand Roy of Sahid Colony, near IOC gate, PS- New Jalpaiguri, Dist.- Jalpaiguri under arrest along with following seized articles;

1. 12 (Twelve) Nos sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.
2. 09 (Nine) Nos sealed Bottles of Kingfisher imperial Strong Beer, each bottle 650 ml, Marked as Exhibit-B from which 01 bottles taken as sample for examination Marked as Exhibit-B1
3. 04 (Four) Nos sealed Bottles of Tuborg Strong Premium Beer, each bottle 650 ml, Marked as Exhibit-C from which 01 bottles taken as sample for examination Marked as Exhibit-C1

I am submitting a written complaint against the above noted accused person to the effect that on 04.04.24 at 19-15 hrs received source information that one person was selling liquor illegally from his shop at I.O.C. More under New Jalpaiguri PS, Dist.- Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself alongwith ASI Dhruvo Mishra C/1462 Sajam Tamang, C/152 Abdul Karim Mia all of NJP PS, SPC left for I.O.C. More to verify the veracity of information vide NJP PS GDE No. 200 Dated- 04.04.24. On arrival at the spot at 19-45 hrs it was found that one person mentioned above was selling liquor illegally from his shop at I.O.C. More to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses namely (1) Monoranjan Das (42) S/o Jatin Das of Sahid Colony, Bhaktinagar PS NJP Dist. Jalpaiguri and (2) Dinesh Das (44) S/o Gyamanta Das of Sahid Colony, Bhaktinagar PS NJP Dist. Jalpaiguri I recovered the above noted articles from his possession from his shop without named and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 19-55 hrs to 20-35 (seizure Total approx 15.6 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Dulal Roy (59yrs) S/O Lt. Bhogchand Roy of Sahid Colony, near IOC gate, PS- New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
