Sir,

I, SI Binup Mahato of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Mithun Das (40 yrs) S/O Lt. Ganesh Das of Bhaktinagar pipe Line Ward No. 35 PS- New Jalpaiguri, Dist.- Jalpaiguri under arrest along with following seized articles;

1. 36 (Thirty six) Nos sealed Bottles of Himalayan FATA FATI India made Liquor 70up, each bottle 300 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.

I am submitting a written complaint against the above noted accused person to the effect that on 05.04.24 at 21-05 hrs received source information that one person was selling Liquor Illegally from his shop named as Ganesh Hotel in front of I.O.C. Gate under New Jalpaiguri PS, Dist.- Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself along with ASI Dhrubo Mishra, ASI Khagen Barman, C/1462 Sajan Tamang, CV-84 Niru Yadav all of NJP PS, SPC left for I.O.C. Gate to verify the veracity of information vide NJP PS GDE No. 263 Dated- 05.04.24. On arrival at the spot at 21-35 hrs it was found that one person mentioned above was selling liquor illegally from his shop i.e. Ganesh Hotel in front of I.O.C. Gate to his designated customers to earn huge money for his livelihood. On seeing the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered the above noted articles from his possession from his shop without named and seized the same as per proper seizure list and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as it's a violation under Bengal Excise Act. The seizure & arrest was made in between 21-55 hrs to 22-35 (seizure Total approx 10.8 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Mithun Das (40 yrs) S/O Lt. Ganesh Das of Bhaktinagar pipe Line Ward No. 35 PS- New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
