In producing herewith three (3) accused persons namely 1. Tapash Mandal (32) S/o Lt. Niranjan Mandal of Baribhasa, Madani Bazar PS NJP Dist. Jalpaiguri (2) Biswajit Roy (19) S/o Sanjib Roy of Jaleswari near Sabjee Bazar PS Bhaktinagar Dist. Jalpaiguri (3) Gopal Mandal (28) S/o Ganendra Mandal of Subhashpally, Lichu Bagan W.No. 18 PS Siliguri Dist. Darjeeling along with seized articles viz

1. One iron rod having length approx 2 ½ feet from the possession of accused person Tapash Mandal.
2. One iron made "Bhojali" measuring approx 15 " inches including butt from the possession of accused Biswajit Roy.
3. One iron made "Sabol" length approx 3 feet from the possession of accused person Gopal Mandal.
4. One Electronic touch light from the PO.
5. Two special Cigarette open packets in containing 16 pcs Cigarette from the PO.

I ASI Dhrubo Mishra of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 7/8 persons to the effect that on the night 05/06.04.24 at 00-05 hrs received secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at Porajhar under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 279 dt. 06.04.24. As per your kind direction myself alongwith ASI Khagen Barman, C/152 Abdul Kyum Miah C/1462 Sajan Tamang, CV-297 Putul Roy, CV-306 Biswajit Roy with night mobile van officer ASI Monaj Majumder and force left from PS for Porajhar to verify the veracity of the information and to work upon it vide NJP PS GDE No. 280 dt. 06.04.24. We reached near the spot as confirmed by the source at about 00-45 hrs and stopped out vehicle at a considerable distance from that place and we started walking towards the said place and we reached near Porajhar near Bridge, found a group of 10/11 persons assemble and gossiping in a dark place at Porajhar near Bridge under NJP PS. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the 03 (three) persons noted above and the others 7/8 persons managed to flee away from the spot. On interrogation they disclosed their identity which not verified and they also stated that they alongwith their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Porajhar under NJP PS. Thereafter all the apprehended persons were searched and due to late night could not found any independent witness to present at the time of search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them. Accordingly I arrested the above noted accused persons u/s 41 Cr.P.C. The seizure and arrest made in between 01-05 hrs to 02-05 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against the 03 ( three ) accused person namely 1. Tapash Mandal (32) S/o Lt. Niranjan Mandal of Baribhasa, Madani Bazar PS NJP Dist. Jalpaiguri (2) Biswajit Roy (19) S/o Sanjib Roy of Jaleswari near Sabjee Bazar PS Bhaktinagar Dist. Jalpaiguri (3) Gopal Mandal (28) S/o Ganendra Mandal of Subhashpally, Lichu Bagan W.No. 18 PS Siliguri Dist. Darjeeling and 7/8 other persons and arranged for its investigation.
