

brother name Abis Chakraborty, Age - 13+ years and my
brother cum driver Angad Pashwan, Age - 36 was driving
my father's car. Sir Angad Pashwan who is my driver plus
brother who was driving our car through Saktigarh
Yuba Sangha Club and then suddenly my brother Abis
Chakraborty who is a child, he wanted to click a picture in the
driving seat badly so our driver let him sit in that place
when our car was stopped, I mean when our car's engine was
off. Then some men all around 18-55 years age came with
a toto driver and started abusing my driver Angad Pashwan
and my brother Abis Chakraborty. They accused that Angad
Pashwan gave my brother to drive which was a false. They
did not listen any word of my brothers and snatched Angad
Pashwan out of the car and beat him like anything. And then
they came to my brother and also start abusing him and
started slapping him who is only 13 years old sir. They also
started abusing my brother, they all were drunk. My
father is an officer in police name ASI Krishnendu
Chakraborty (Bapi Chakraborty) who is recently posted in
Panitanki Traffic Guard and my uncle who is an OC
in police (Airview more) name Dipendu Chakraborty.
