I, Sri Kamaljeet Singh Punia, Son of Late Naseeb Singh Punia, resident of Sister Nivedita Raod, Deshpriya Sarani, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, West Bengal, like to bring to your notice the following facts:-

- 1) That my son Charan Deep Singh Punia is running a lodge under the name and style of 'Ratna Lodge' at Sevoke Road, Siliguri w.e.f. 01.06.2021 under the ownership of one Sri Amulya Ghising, Son of Late Dhan Bahadur Ghising of Patharghata Road, Salbari, Dist. Darjeeling.

Be it mentioned here that I am engaged in look after of the aforesaid Lodge business since the very inception of the same by my son.

That the owner of the building Amulya Ghising is a man of hot temperament, very adamant and rude in nature. He often comes to the counter of the Lodge in drunken condition and causes disturbance in running of the business. I have requested him on several occasions not to create such nulsance and disturbance in the business premises which causes bad reputation to our business and the guests (boarders) feel disturbed and annoyed due to such breach of peace and tranquility in the premises caused by his such behaviour.

- 3) That on 05.04.2024 at about 7:00 p.m. / 7:30 p.m. said Amulya Ghising came to our Lodge in totally drunken condition and started shouting without any rhyme and reason. When I told him not to shout in such manner, he lost his temperament and started assaulting me with fists and blows with wrongful intention to cause grievous hurt to me. After this said Amulya Ghising left the premises threatening me that he will kill me on the next occasion.

I sustained injuries due to such attack and went to the Doctor for treatment.

I am passing my days in great anxiety, fear and tension alongwith my family due to such attack and threat and would therefore request to take immediate necessary steps against said Amulya Ghising according to law and oblige.
