Sub:- Written Complaint.

Respected Sir / Madam,

I, Smt. Monolisha Saha, W/o. Sri. Gourav Thakur, D/o. Sri. Biplop Saha, R/o. 29, Tilak Road, Hakimpara, Ward No.12, P.O. & P.S. Siliguri, Dist. Darjeeling would like to inform you that on 14.07.2023 out of love and affair one Hindu Marriage was solemnized between me and a person namely Sri Gourav Thakur, S/o. Sri. Gopal Thakur, R/o. NH 31 Dumaria Bhatta, near Bengal Medical Hall, Ward No. 29, P.O. Kishanganj, Dist. Kishanganj (Bihar) as per Hindu Rites and customs at my above noted residence and during that marriage ceremony parents, family members as well as well-wishers of both of us were present and at the time of marriage as per demands of my husband and his parents and his family members namely Sri. Gopal Thakur, S/o. Lt. Jagdish Thakur (Father-In-Law), Smt. Jharna Thakur, W/o. Gopal Thakur (Mother-In-law), Sri. Subhas Roy, S/o. Not known (Brother-In-law), Smt. Moumita Roy, W/o. Subhas Roy (Sister-In-Law), Sri. Pradip Paul, S/o. Not Known (Brother-In-Law) and Smt. Susmita Paul, W/o. Pradip Paul (Sister-In-Law) my parents also gave them a sum of Rs.1,50,000/- ( Rupees Fifty Thousand ) Only by cash and also gave one Gold Neckless, Two pair of ear rings, golden finger rings etc and also gave other household articles such as Khat, Desintable, Almirah etc and after aforesaid marriage I went to my matrimonial house as mention above and also one reception ceremony was also organized the next following day at Line Para, Buri Kali Mandir, Kishanganj and after the said ceremony we started living together as a husband and wife at matrimonial house in a joint family.

I would also like to mention here that after 8 days of my marriage when I came to my parental house along with my husband for "Astomangal" on that very day he ran away from my parental house without informing anyone why he went away without any reason and also he did not fulfill the rituals for "Astomangal" thereafter I stayed at my parental house for few days and after that due to intervention of my parents and after several request he once again came to my parental house and return back me to the matrimonial house and after 15 to 20 days of the aforesaid incident my husband came to siliguri along with me and started to live together at a rented house at khelagore More, Siliguri because my husband worked at Siliguri in a Reliance Jio Infocomm Ltd. as an H.S.T.L. and at the time of living with my husband I noticed that my above named husband came to the rented house at late night with drunken condition and after coming to home he always started to abuse me by using filthy languages and also tortured me by way of physically and mentally but I tolerated the same because I hoped that one day he will change his behavior in respect of me but such day never came into my life and during this period I also informed the aforesaid incident to my above named In-Laws but they did not pay any heed to my said intimation but inspite of the same the above noted all In-Laws after making some criminal conspiracy with my husband they induced my husband to torture me by way of both physically and mentally and during this period I was pregnant and at that time my all In-Laws several time came to my rented house and this time also all of them including my husband after making conspiracy they did not provide any proper food and daily necessities to me despite of saying several times but still they continued to increase their inhuman torture towards me and threatening me and also did not provide basic needs which was mandate for our baby.

Thereafter on 18.01.2024 we gave birth to one female child namely ~~Gungun Thakur~~ at Basus Clinic Health Care Pvt. Ltd. and during that period also my husband was not present when I required him the most even though my parents called him several times but he did not pay any heed soon after when I came home from the hospital he again started the same immoral behaviour towards me and also he did not give any kind of love affection towards me and my female child and also did not provide any proper foods and clothings to our child.

It is important to mention here that after few days of the aforesaid incident we shifted to another rented house at Girish Ghosh Sarani, Opposite Jhosna Bakery, Siliguri and this time also he did not change his behavior in respect of me, ultimately on 02.03.2024 at about 9 p.m. my husband came to home with drunken condition and after that he over telephone contacted with other In-Laws and thereafter they all of them made a criminal conspiracy and after taking advantage of my sleeping he entered into my bedroom and he took one pillow and he intentionally tried to kill me by way of stopping of my breathe and when I somehow saved me from the said incident by seeing me alive he again took one sharp cutting broken glass and intentionally tried to kill me for which I sustain severe injury in my hand and somehow I saved me and my baby from him and I went to Siliguri District Hospital and treated there as a indoor patient and I also informed the said matter to the Panianki T.O.P. and the concern police station came to the spot and gave him warning and also gave him one last chance and I also after thought better future of my female child did not lodged any complaint against my husband over the aforesaid issues and thereafter once again I started my conjugal life with my husband but all are in vain because once again on 30.03.2024 at about 05 p.m. my husband came in front of my parental house and used slang languages in respect of me and my parents and when me and my parents tried to protested the same at that time he assaulted me and my parents with fist and blows and thereafter he left the place and since then I reside at my parental house and right now the aforesaid all persons threatened me with dire consequences So, right now I spend my days with in fear due to aforesaid reasons no other alternative way today with help of my well wishers I lodged this Written Complaint before you against the above noted persons.

Therefore I request you be please take necessary legal action against the above noted persons and also save me from their hands as early as possible.
