I Smt Mina Moitra, Wife of Sri Jibendranath Moitra, resident of 1st Floor, Shiva II Apartment, Rajani Kanta Sarani, Ward No.16 of S.M.C, Hakimpara, P.O & P.S-Siliguri, District-Darjeeling, Pin-734001 do hereby inform you that my son Sri Kaushik Moitra got married to one Smt Poulomi Sarkar, Daughter of Late Pulakesh Sarkar, resident of West Keranipara, P.O-Jalpaiguri, P.S-Kotwali, District-Jalpaiguri on 06.02.2006 as per Hindu rituals and customs, subsequently on 14.03.2011 out of the wedlock of my son and my daughter in law Smt Poulomi Sarkar (Moitra) one male child namely "Master Kanjanava Moitra" was born.

Later on March, 2018 Smt Poulomi Sarkar (Moitra), i.e. my daughter in law left her matrimonial house i.e. her husband's company by deserting him and went to her paternal house at Jalpaiguri, she took the minor son along with her.

Thereafter in the year 2020 my son Sri Kaushik Moitra filed a contested divorce application against her, later she also did lodge maintenance cases against my son before different forums.

On 12.02.2024 my son filed an application for custody of his son "Kanjanava Moitra" and as a result of which on 21.02.2024 my daughter in law lodged a false case being Siliguri P.S Case No.154 of 2024 dated 21.02.2024, U/S 498A of I.P.C, r/w Section 3 & 4 of D.P Act

against our whole family i.e. 8 members. Subsequently we complied with the notices which were served upon us and thereafter we were granted bail by Ld A C J M. Siliguri on 05/04/2024

Somehow Smt Poulomi Sarkar (Moitra) came to know that I along with other family members were granted bail by the Ld. A C J M Court

Yesterday (06/04/2024) at about 05:30 to 6:00 P.M. Smt Poulomi Sarkar (Moitra) along with her mother Smt Anurupa Sarkar, brother Sri Prasenjit Sarkar, sister Miss Pallabi Sarkar and maternal aunt Smt Shukla Sur, all residents of West Keranipara, P.O. - Jalpaiguri, P.S. - Kotwali, District - Jalpaiguri, Pin-735101 came to our residential flat and started beating me (aged 77 years) and my 82 years old husband Sri Jibendranath Moitra and threatened us of filing false criminal cases against us no matter we being senior citizens

They also forcefully took the gold chain weighting 34 grams which I wear in my neck. They have further threatened us with dire consequences if my son do not give Smt Poulomi Sarkar (Moitra) a permanent alimony of Rs 30,00,000/- (Rupees Thirty Lakhs) only

I state that I am aged about 77 years old and my husband is 82 years old and are suffering from multiple ailments and we do not have any other options other than to take refuge before the Police authorities for our safety and wellbeing.

I therefore request your good office to look into the matter and take stringent action against all the above named miscreants so they can be booked as per the law of the land.

Please treat this as very urgent and do the needful
