- (1) That Sir, I am running a MOMO fast-food shop adjacent to my residence to meet our living wage.
- (2) That on 11/03/2024 at about 7.30 PM above named **Sri Santosh Hazra** accompanied by his friend called **Sanjay @ Sanhju** came to my shop and ate MOMO amounting to Rs. 60/- and they paid bill through online (Mobile).
- (3) That within few minutes they came back to my shop again and intimate me that they by mistake paid the bill twice i.e. Rs. 120/- so started arguing to return Rs. 60/- and suddenly started quarrelling with me and my nephew **Sridam Sarkar**.
- (4) That then they started using filthy languages to insult the modesty against us and started assaulting my nephew and my sister-in-law with fist and blow and when I tried to restrain them I was also physically assaulted causing physical injuries by them and then above named **2) Sri Probir Hazra, 3) Sri Mithun Hazra, - all are sons of Late Godai Hazra, 4) Smt. Mishtu Hazra, W.O Sri Santosh Hazra, 5) Smt. Anjali Hazra, W.O. Late. Godai Hazra** also joined with Lathis and metal weapons and intensified the attack and ransacked all the table chair of my shop.
